

LABOR CASUALTIES ALSO HEAVY VFW CONVENTION TOLD

4,681,700 Killed or Injured
Since Pearl Harbor, AFL
President Green Relates.

Chicago, Aug. 23.—(U.P.)—William Green, president of the American Federation of Labor, said today labor has suffered 4,681,700 casualties "while serving on so-called 'safe' jobs on the production line" since Pearl Harbor.

"Of this total, 36,500 workers have lost their lives, while 122,300 have become permanently disabled," he told the 45th annual encampment of the Veterans of Foreign Wars.

Plans Outlined
Green outlined labor's accomplishments and plans for post-war rehabilitation of veterans injured in war, but warned that to "offer them hospitalization is not enough."

"To leave them to the care of charity after their hospitalization ends would be a criminal disgrace," he said.

Brig. Gen. Frank T. Hines, administrator of veterans' affairs, said there were 209,348 veterans of the present war who are now receiving disability pensions, with 47,701 disability claims upon which final action has not been taken.

"There were on June 30, 27,385 death pension cases approved, involving 13,430 widows, 8183 children and 23,252 dependent parents, a total of 44,865 individual dependents on the pension rolls because of service in the present war," he said.

\$39,745,416 Paid
Hines said the veterans' administration had paid out in disability pensions to the end of May a total of \$39,745,416, and the total paid out in death pensions was \$18,725,375.

Carl J. Schoeninger, Detroit, commander-in-chief of the VFW, said "if delay in post-war planning and conversion procedure means that we shall be able to save the lives of thousands of Americans, then I am ready to take my chances with another depression."

"Let's leave the post-war plans to the experts who are qualified to do the job," he said.

Schoeninger suggested that the encampment adopt resolutions insisting that combat veterans of this war be included in the American peace conference delegation, immediate adoption of a universally compulsory military training system as a permanent peacetime police for the United States, and fair and equitable distribution of surplus war materials with priority purchasing privileges for overseas veterans.
