SUBMARINE LOST IN PACIFIC AREA

Washington, Dec. 28 (AP)—The 1450-ton submarine Seawolf is overdue on Pacific patrol and presumed lost with its crew of at least 82 men, the navy announced today.

This was the 34th U. S. submarine to be lost from all causes in this war and the 239th American naval vessel lost. Our submarines, however, have sunk 934 Japanese ships.

Skipper of the Seawolf was Lt. Comdr. Albert M. Bontier, White Plains, N. Y. He was a native of Canby, Kan. Silent, living "personators" enacted the parts of dead ancestors in the family worship of ancient China.
