

NAZARENE PASTOR HAS FIFTH BOOK WITH PUBLISHER

OPTOMETRY BILL ARGUED IN HOUSE

Salem, Ore., Feb. 16—(U.P.)—The Oregon house committee on medicine, pharmacy and dentistry today held under advisement lengthy arguments on HB272, which would permit firms and corporations to hire licensed optometrists as at present.

The bill by Rep. John Steelhammer, Salem, was the outgrowth of court action underway in Klamath Falls, where an optical company is seeking to remain in business with the use of licensed optometrists, a procedure permitted since 1912. Sponsors said passage of the bill would continue this permission in event of an adverse court ruling, which otherwise might put out of business various companies now operating.

Opposition came from the Oregon Optometric Association, the state board and others contending that optometry was a profession and the steady growth of the craft was threatened when unlicensed persons were permitted to have a part in it.

STORAGE STOCK OF FOOD DROPS

Washington, Feb. 16—(U.P.)—New evidence that the nation's food supply is dwindling came today when the government reported that cold storage stocks on February 1 had dropped to the lowest point since July, 1943.

Storage holdings of all meat were at a record low, a monthly war food administration report showed. Stocks of 615,700,000 pounds were only a little more than half the size of a year ago. These included substantial government holdings. Beef stocks were down more than 50 per cent and pork almost one-third.

Total stocks in public warehouses, including both civilian and government food, declined 14 per cent during January. Almost every major item on the family diet was included. Supplies of butter, creams, eggs, fish, poultry, lamb, fruits and vegetables all declined 10 per cent or more.

Correct Method Of Addressing Letters To Freed Personnel

Washington, Feb. 16—(U.P.)—The War Department today issued instructions for addressing letters to military and civilian personnel liberated from Japanese camps on Luzon Island.

The correct method of addressing such letters is as follows:

Name of person
(Use serial number for military personnel)

American Red Cross
Civilian war affairs section
APO 442, care of Postmaster
San Francisco, Calif.

The War Department said mail will be limited to letters and postcards. It should be addressed in this manner only when destined for recently released personnel. Regular mail service between the United States and Luzon for other civilians will be resumed at a later date.

Every effort will be made to send all mail for liberated prisoners by air mail, the War Department promised.

YOUTH LECTURED FOR MASQUERADE

A local youth, 18, charged with misrepresenting his age for the purpose of purchasing a glass of beer, was halted before Justice of the Peace W. P. Tucker yesterday. He was allowed to go after his mother had appeared. She stated the lad had been permitted to drink beer at home but was forbidden to do so in public places.

The youth, authorities said, had an age certificate, obtained in California, with changes made after erasure, to show he was 21 years of age.

According to county officials a number of similar attempts have been made recently by the younger class. Under Oregon law a minor is prohibited from misrepresenting his age, and it is unlawful for a third person to represent a minor to be other than his true age. The penalty is \$50 and 30 days in the county jail, in either case.
