IN THE DISTRICT COURT OF THE UNITED STATES FOR THE DISTRICT OF OREGON, UNITED STATES OF AMERICA, v. 37 Cases, more or less, containing 48 5-ounce packages Candy, 20 Cases, more or less, containing 24 1-pound packages Candy, PUBLIC NOTICE IS HEREBY GIVEN THAT on the 27th day of April, 1945, 37 Cases, and 19 Cases and 11 Packages Candy were arrested and taken into the possession of and now are in the possession of the United States Marshal for the District of Oregon, pursuant to a warrant and process duly issued by the Clerk of the United States District Court for the District of Oregon, in a suit for condemnation and forfeiture entitled Libelant vs. 37 Cases, more or less, containing 48 5-ounce packages Candy, 20 Cases, more or less, containing 24 1-pound packages Candy brought under the provisions of Section 334, Title 21, U.S.C.A., wherein it is sought to have the above-described article of food condemned and forfeited for the following reasons: That on or about the 7th day of March, 1945, and 12th day of March, 1945, the said candy was shipped in interstate commerce from San Gabriel, California, to Medford, Oregon; that the said candy is adulterated within the purview of Title 21, United States Code, Section 342(b)(2), in that a mixture containing peanuts and puffed rice has been substituted for Spanish nut toffee, which article purports to be and is represented to be that the said candy is misbranded within the purview of Title 21, United States Code, Section 342(d) in that its container is so filled as to be misleading; that all persons claiming any right, title or interest in and to the said candy are hereby notified to appear on or before the 4th day of June, 1945, in the Federal Court at Portland, Oregon, to show cause, if any there be, why the same should not be decreed against and forfeited to the United States as adulterated and misbranded food.
