PROTECTIVE FOODS

Milk, egg yolk, cheese, green leaves, vegetables both raw and cooked, peanuts and nuts are the high calcium foods and all of these foods are now classified as "protective" foods because they supply calcium which the ordinary refined diet so commonly fails to supply in sufficient amount, and they supply all of the vitamins required to maintain good nutrition—vitamins which the ordinary refined diet in America generally fails to supply in sufficient amount for good nutrition.

Owing to the lack of significant amounts of vitamin D in the ordinary American diet (the few items containing any supply in sufficient—milk, cream, butter, egg yolk, canned salmon), every child, youth and adult needs a good ration of natural or synthetic vitamin D to supplement the ordinary diet in the year around, particularly in the season or in the environment that deprives the individual of the influence of sunlight on the skin.

Thanks to the characteristic ballyhoo of the nostrum vendors, most of whom now sell vitamins to bolster up the old line of dope for that tired feeling, the child-minded portion of the population (numbering thirty or forty million morons, the psychologists say) regard a "shot" of vitamins as something that gives one a "pep," cures various chronic or persistent ailments or "helps" (as the funny federal regulations insist the spellers say) to build or maintain "resistance to colds"—whatever that may mean.

Whether we are speaking of vitamin D, of the anti-gray hair vitamins, of B-complex or any other vitamins or of calcium or phosphorous or any other min-

erals, or of iodine as in the iodine let me emphasize that it is food, not medicine, and any improvement in your nutritional state, your vitality or health which you may experience from supplementing your ordinary diet with any of these vitamins or minerals will not last if you stop taking the vitamins or minerals after a few weeks or months and return to the deficient diet on which you developed your weakness, run down condition or impaired health and vitality.

In the pamphlet "The Anti-Gray Hair Vitamins" (copy on written request if you provide stamped self addressed envelope) I say that an increase in vito and sense of well being experienced in the first few months of the course should be taken as a favorable sign. It should at least encourage one to continue taking the vitamins for at least a year. Hair doesn't turn gray over night or in a month. It is unlikely that the graying process can be stopped, much less reversed, in less than a year. Or any other manifestation of premature senility.

QUESTIONS & ANSWERS
Have Apple for Diarrhea
Please tell me if you have recommended giving young infants raw apple for diarrhea. A neighbor says you did but I feel sure she is mistaken. (Mrs. H. M.)

Answer—For acute diarrhea, in infant or child or adult, a diet consisting exclusively of peeled and washed or scraped raw apple and very weak tea, for a day or two, is excellent treatment. All the raw apple pulp the infant, child or adult will eat.

Appendicitis Pain
Several times recently I have had a sharp pain in the right side of the abdomen. It subsides in an hour or two. Is it likely to be appendicitis? (D. C.)

Answer—No. The early pain of acute appendicitis is almost always in the epigastrium, the region of the "pit of the stomach." Only later in the course of the illness is rigidity and tenderness in the right lower quadrant of the belly manifested.

2,000 Returnees At San Francisco
San Francisco, Sept. 20—(U.P.) The troop ship Sea Runner today brought home approximately 2,000 soldiers, sailors and marines from New Caledonia, Guadalcanal, and the Russell Islands for discharge or reassignment. Three other ships were scheduled to arrive tomorrow with more than 7,000 military, naval and civilian passengers. The Monterey will carry 4,200 soldiers; the President Johnson, 1,429 sailors, and the Afoundia, 1,000 soldiers, 129 sailors and 500 civilians from Hawaii.

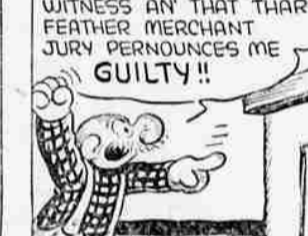

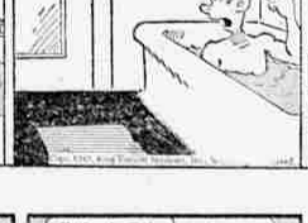
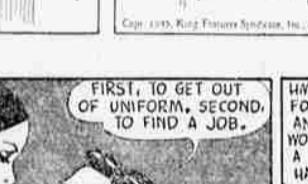
