ALL GOD'S CHILLUN HAVE TONSILS AND ADENOIDS

A series of X-ray treatments will bring about shrinkage of adenoids in many instances where the child's hearing is evidently impaired by obstruction of the mouths or openings of the Eustachian tubes. The Eustachian tubes connect the nose-throat cavity with the middle ear cavities where those three famous little bones—hammer, anvil and stirrup—are housed. At least X-ray treatment is worthy of a fair trial before submitting the child to operation for removal of adenoids.

Some physicians have employed X-ray treatments successfully for enlarged tonsils, whether with or without adenoid enlargement.

There is just one way a physician can determine positively whether a patient has adenoids—by feeling them with a finger introduced behind the soft palate into the vault or upper space of the pharynx or throat, the nose-throat cavity, or by seeing an image of the adenoid mass in a throat mirror by means of head lamp. If the physician does not use one or the other method to examine the patient his diagnosis of "adenoids" is only a guess—and may be wrong.

Far too many children have been subjected to crude and unnecessary surgery for "adenoids" they didn't have.

The scandalous racket in wholesale tonsil and adenoid operations which flourished in the years that are gone left one wrong impression on the popular mind and another on the medical mind.

The impression left in the mind of the layman is that the presence of tonsils and adenoids is abnormal in itself. The truth is, of course, that all healthy children have tonsils and adenoids, which serve two useful purposes—first, they manufacture blood corpuscles, and second, they protect the body against bacterial invasion.

The wrong impression still harbored by too many physicians and specialists is that the lymphoid tissue of the tonsils and adenoids body is in itself harmful and must be completely eradicated to insure success from the operation. This notion is so absurd and amateurish that I am sure no reputable physician, surgeon or specialist will even attempt to defend it today. Nevertheless it is the sorry ground on which a good many quacks in ethical clothing contrive to damn the work of

honest doctors in the eyes of gullible patients and keep their own atrocious surgery in demand. If you ask me, folks, or even if you don't, I'll say that in my opinion even now far too many children are subjected to this American atrocity because the physicians and specialists who commit the atrocity have no clear conception of the pathology of the nature of the condition they are treating. They just advise and do the operation because it is conventional and they know nothing else to do.

Answer—Thank you, Mrs. E. S. I notice you live in the entire belt, the Great Lakes basin, where there is a deficiency of iodine in soil, drinking water and animal and vegetable food grown on the soil.
