

## Mental Aid Clinic Seen Obtainable In Jackson County

A total of more than 200 persons attended sessions of a conference on mental health which was held here yesterday.

Melvin Murphy, Portland, director of the Oregon Mental Health association, was speaker at morning, noon and evening meetings.

Murphy told those attending that it would be possible for Jackson county to obtain wider child guidance and psychiatric services than at present obtainable. He explained that the traveling clinic maintained by the University of Oregon medical school will no longer be sent to communities where the sponsorship is limited.

But he pointed out that through cooperative endeavors of volunteer groups, present organizations and agencies such as the juvenile court, the welfare office and the schools, a regular schedule of visits could be set up in this area, perhaps through the cooperation of Southern Oregon college.

He praised Jackson county for setting up the first organization of which he has heard for child services, and emphasized the importance of mental health work by pointing out that Oregon has the highest suicide rate of any state in the nation, and one of the highest divorce rates.

**New Developments**  
His association, he said, is interested in interceding on behalf of those with mental illnesses, and training teachers, parents and others how to avoid mental illness. New developments in Oregon recently, he reported, include the location here of two new psychiatric hospitals, and the setting up of a school at the university for training in psychiatric social work.

Dr. William Thompson, vice-chairman of the Jackson County Council for Children and Youth, presided at the morning meeting in the YMCA and explained the council's purposes. A film, "Angry Boy," dealing with a youth who steals and is cured by psychiatric help, was shown and discussed.

**Workshop, Film**  
During the afternoon a "workshop" for school officials and law enforcement officers on truancy problems was held, and in the evening another film, "Feeling of Rejection," was shown at a meeting in the junior high school. This picture showed the influence of the home and parents, and the school and teachers, on young people.

During the day Murphy urged support for a proposed constitutional amendment which would permit the construction of a state institution for mental patients in Multnomah county, and pointed out that more than half of the patients at both Salem and Pendleton mental hospitals come from the area surrounding Portland.

A new hospital would permit better treatment for those needing it at all three hospitals, plus better custodial care for senile patients from the metropolitan area, he said.

## 1952 March of Dimes Exceeds Prior Years

The Jackson county March of Dimes in 1952 exceeded by more than \$9,000 the amount raised in 1951, previously the best year in the history of the Dimes march, it was reported here today.

Harry Chipman, chairman of the Jackson county chapter of the National Foundation for Infantile Paralysis, said that the total gross collections here this year were \$26,039.37, compared to \$17,245.44 in 1951, and that the net was \$24,861.54, compared to \$15,830.51 last year.

**Half Stays Here**  
Roy Huson and George Schuler, co-chairmen of the county-wide fund campaign, said that half of the net figure will be retained in the county to care for polio case expense here, and that the other half will go to the national foundation for research, treatment and epidemic expenses and reserves.

The drive leaders pointed out that the tremendously successful drive would not have been possible without the wholehearted cooperation of everyone involved.

"There were too many people who helped us to name them individually," they said, "but we would like to express our heartfelt thanks to everyone. It was terrific."

In Medford the total raised was \$16,506.83, compared to \$7,955.10 last year. Other totals from areas included:

## Clackamas Court Demands Payment OF O&C Land Funds

Oregon City — (U.P.) — The Clackamas County Court demanded Thursday the distribution of nearly \$5,000,000 in revenues from controverted O & C lands.

The court specifically demanded federal officials give the county its share of the money which amounts to \$180,880.

**Based on Distribution**  
 The claim was based on the rate of distribution given on other O & C lands under the Bureau of Land Management, rather than under the Department of Agriculture. If the funds are distributed by the forest service, a branch of the Department of Agriculture, the county's share would be \$48,904.

Clackamas county attacked withholding of the funds by the government on grounds the lands that earned the money were under the jurisdiction of the Department of the Interior at the time the sales and rental were made.

The two governmental agencies disputing which has jurisdiction over the lands and all funds from sales and rentals were withheld pending a settlement.

After discussion, the group voted to recommend to the council that a board of review be set up to screen magazines received here, and notify city police of titles which they feel are objectionable.

**Ordinance on Books**  
 There is already a city ordinance forbidding the sale of obscene printed material in Ashland, but Chief of Police Vern Smith pointed out that his department is not organized to screen the many magazines and determine their worth.

The conference, which had been called at the request of the Rev. W. H. Tillman, voted for a three-man review board, with representatives of the public, the ministerial association and the schools as members.

The council was due to meet in special session today or Friday to set up such a board, which might have three or five members.

Gary, 42, a Richmond, Calif., building contractor and a war veteran, moved into the white frame house Wednesday. He had received warnings his presence would be unwelcome.

The crowd began gathering about 6 p. m. Shortly, Gary sent five of his seven children to stay at their old apartment in Richmond. He remained at home with his two oldest children and a white neighbor, George Eldredge.

At one point, Eldredge went out on the porch in an attempt to quiet the crowd.

"They told me to mind my own business," he said. "They called me 'nigger lover'."

Shortly after 10 o'clock, the Rev. Fred H. Busher, pastor of St. Luke's Methodist church in Richmond, arrived with some 40 church members. He planted the American flag in front of Gary's home, then turned to the crowd and began to read the Declaration of Independence.

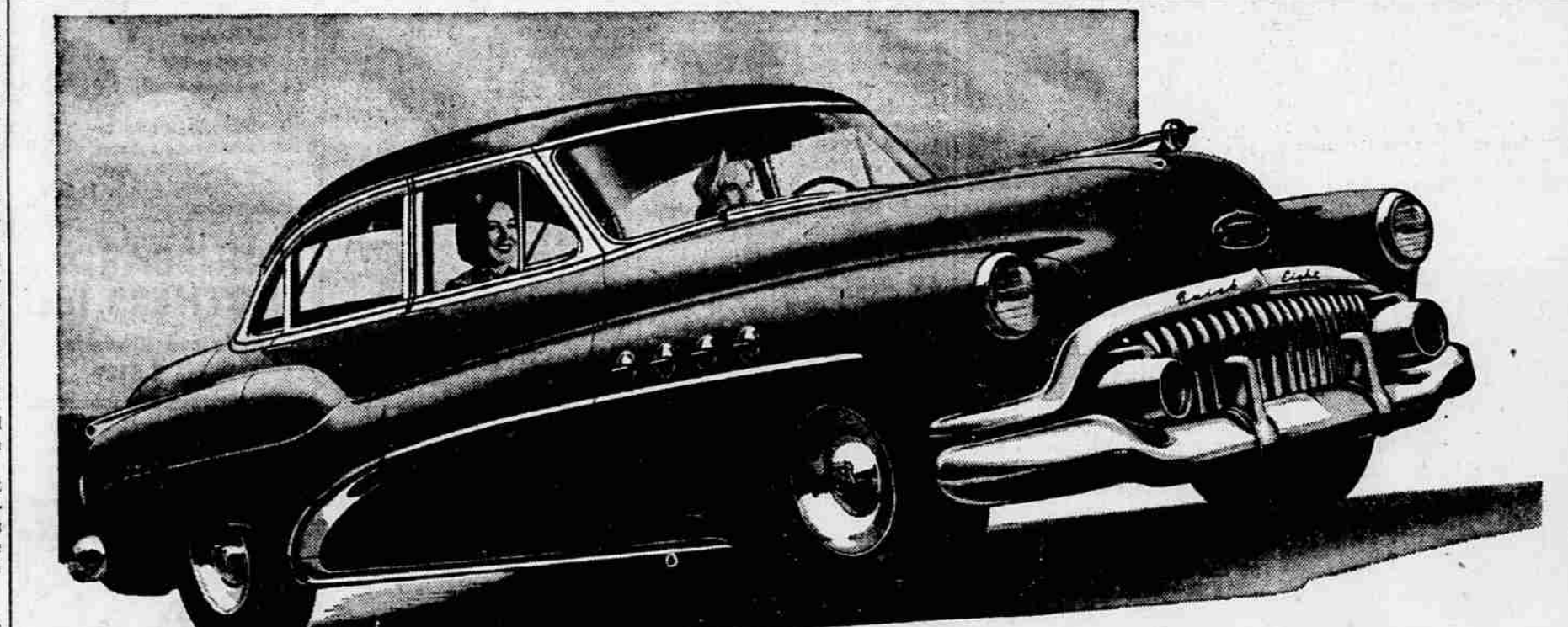
