Bandon Man Killed In Car-Truck Wreck

Coquille—(UP)—Daniel Harrison Blake, 41, Bandon, was killed Friday night when his car smashed head-on into a loaded log truck on the coast highway just outside of Coquille.
The driver of the truck, Earl Clifton Hartley, Coquille, said he saw Blake's vehicle come around a curve and onto the straightaway, then drift "squarely" in front of the truck on the wrong side of the pavement.
Sgt. Howard Marsh of the Oregon State police said he had evidence that Blake had been drinking and officers had been attempting to chase down a car resembling Blake's after other motorists reported it was being driven erratically.
