

Bowerman Charges Youths' Move Violates Spirit of PCC Rules

Eugene — (U.P.)—Controversy over a former Portland high school star's decision to attend Oregon State college instead of the University of Oregon appeared today to be headed for an investigation by Pacific Coast Conference officials.

Bill Bowerman, assistant athletic director at Oregon, identified the athlete involved as Bob Clark who was a football and basketball star at Benson Tech in Portland last year. He charged that four OSC representatives escorted Clark from the Oregon campus.

Bowerman charged it was in violation of the spirit of PCC regulations. He planned to meet today with Dean Orlando J. Hollis, Oregon's faculty representative and conference president.

In Portland, Mrs. Donald Clark, mother of the boy involved, said her son's intentions were to return to OSC today and register. She said he always felt that he "would be more at home with his friends at Oregon State."

Duck Eyeing 1st Division

Portland — (U.P.)—Upset minded University of Oregon Webfoots return to the football practice field today with their sights set on a first division finish in the Pacific Coast Conference while Oregon State's Beavers hoped for the return of several injured regulars.

Oregon's triumphant Ducks, 20-12 victors over Nebraska at Lincoln Saturday, were greeted on their arrival at Eugene yesterday by a joyful band of followers. The victory put the Ducks among only three conference teams that posted victories on the opening weekend of the football season.

The Beavers, who suffered the worst defeat of the opening week-end, went down 41-0 to UCLA.

Good Shape
Both teams appeared to have come out without any serious injuries.

It appeared likely that Jack Peterson, left halfback who missed the first game because of pulled muscle, would be back in the lineup next Saturday. And Ralph Carr, also on the injured list, probably will be in shape.

Coach Len Casanova had a great deal of praise for his players, pointing particularly to George Shaw, the play-calling youth who seemed to hit his stride against the Cornhuskers. Casanova also praised Emery Barnes, team captain, who was effective on both offense and defense from his wing post.

Harrington Wins Hudson Cup Tiff

Spokane — (U.P.)—The Northwest's top 10 pros shaded the region's top 10 amateur golfers yesterday 8½ to 6½ to win the Hudson cup for the fourth time in five tries.

In Saturday play George Harrington, Medford, and George Beechler, Ontario, representing the amateurs, lost to Leo Gaulochler, Olympia, Wash., and Larry Lamberger, Portland, 6 and 5, as the pros won the opening round 4 to 1.

On Sunday Harrington posted 2 and 1 victory over Gaulochler.

ELKS OUSTED

Kalamazoo, Mich. — (U.P.)—Oregon City's Elks were out of the running in the American baseball Congress tournament today. Kalamazoo and Oklahoma City both defeated the Elks yesterday to eliminate Oregon City. Kalamazoo choked off a ninth-inning rally to edge the Elks 4-3 and Oklahoma City scored three times in the ninth to win 8-6.

System Reduces Time, Cuts Insurance Rates

Delta, O. — (U.P.)—This community of 2,000 had a metropolitan traffic problem every time the siren blew to summon the 32 volunteer firemen from factories and stores.

Switchboard operators of the local telephone company took at least 10 minutes to notify the volunteers. Then the firemen had to battle their way through the many cars that pulled out to follow the fire truck.

Now, with a specially built alarm system in the telephone office, the operator pulls a master switch joining all the phones of the volunteers when she receives a fire report, alerting them all in less than 10 seconds. The town now gets reduced insurance rates.

Portland — (U.P.)—A one year agreement between the Pacific Telephone and Telegraph Company and the Communications Workers of America (CIO) was reached late yesterday. Some 6,000 Oregon employees are affected.

Union and management sources said wages would be increased from \$1 to \$3 a week, depending on job classifications, location and present wage rate. The company estimated the cost of the raises at \$650,000 annually.

A tentative agreement on wages had been reached Aug. 29, 12 days after the old contract expired. Issues such as seniority, vacations, dismissals, layoffs and

grievance procedure had held up the contract.

Work stoppages had been held in the Eugene, Roseburg and Baker areas. But no strike was

called, although the union approved a strike vote.

Arne Graven, Oregon CWA director, said terms of the agreement would be disclosed later.

Peanuts To Assist Building of Church

Buffalo, N.Y. — (U.P.)—Peanuts will help build a new \$38,000 building for the Mormon Church of Jesus Christ of Latter Day Saints here.

Members from all forms of lotteries and raffles; so when they faced the problem of raising funds, they purchased peanuts in bulk lots, blanched and roasted them, and packaged them for sale.

The blanching was done in the home of Elder Otto J. Lendt, and the roasting and packaging was done by volunteers in member's homes.

Over a two-year period the church has accumulated about \$1,500 selling the peanuts. Members have raised more money by sponsoring dinners and selling handmade flowers.

Ex-Butte Falls Woman Has Poetry Published

Mrs. Alice R. Hall, who was raised in Butte Falls, is the author of a collection of poetry, songs of a sourdough, to be published by Pageant Press, New York City, late in October.

Mrs. Hall, who lived for eight years in Anchorage, Alaska completed her education through several courses given by the Oregon Extension unit. Her poetry has appeared in the Pacific Homestead.

The author now lives in Pleasanton, Calif., where she owns and operates a hotel with her husband.
