California Valley Impresses Russians On Tour of Farms

Fresno, Calif. — (UP)—Eleven Russian farmers declared themselves impressed today with the thriving farmlands and vast distances in California's great Central Valley.

"California farmers are doing wonders in their farming," said Vladimir Matskevich, acting Soviet Minister of Agriculture after a day-long tour of some of the state's richest farm areas yesterday. "Our visit is proving invaluable."

Matskevich and his companions, no strangers to tremendous distances, were nevertheless impressed by the immense amount of territory they covered yesterday.

"But when we look at the map, we see we really haven't gone very far," he said. "We wonder if we'll ever get to Riverside."

Vineyard Tour Today's schedule calls on the Russians to tour the 160-acre grape vineyard owned by Hanser Bros. in Fowler, about 10 miles south of Fresno. They will lunch in Exeter.

In the afternoon, they may tour sections of the Friant-Kern canal and inspect cattle ranches and other farming operations in the Bakersfield areas. They will spend the night in Riverside.

The Russians were up bright and early yesterday. They left San Francisco for Santa Rosa, where Matskevich laid a wreath on the grave of Luther Burbank, the famed botanist.

From there they went to Tracy, where their tour of the Central Valley began. After a Chamber of Commerce lunch, they went to the ranch of Ed Thoming. They inspected sugar beet fields and watched a sugar beet harvester in operation.

Beer Party They ate tomatoes off the vine and later drank beer in the backyard of the Thoming home. "We gave them a lot of beer, as it was pretty hot, about 95, I think," said Mrs. Thoming. "They told me they enjoyed the beer very much after the two-hour tour of the fields."

Nikolai M. Gureev agreed with newsmen that the weather was warm, but declared it was "not so hot as Iowa."

Last night, the Russians were guests at an Armenian shishkebab dinner at the Lone Star School 10 miles southeast of Fresno. Some 300 persons also attended. Matskevich made a few remarks expressing the desire of the Russian people for peace and friendship with America.
