Ford Plans to Sell Common Stock Shares

New York — (U.P.) — The Ford Motor company has made plans for the first public sale of more than \$1,000,000 worth of common stock in the family-owned automobile empire. The Ford Foundation, which owns 88 per cent of the company's securities, announced it will put 6,952,299 Ford shares on public sale in January. Sixty per cent of Ford's voting stock would be sold to public investors. The 40 per cent retained by the family still will give them "working control" of the company. Many huge U. S. corporations are controlled by a considerably smaller percentage of voting stock.
