Bombay, India—Soviet Communist Party boss Nikita S. Khrushchev, giving his interpretation of why the Geneva foreign ministers conference failed:

"We say that no one has the right to interfere in the home affairs of another nation. We are fighting for these principles—the principles of peaceful co-existence."

Washington—Rep. Augustine B. Kelley (D-Pa.) on advisers who might change the political personality of Adlai E. Stevenson: "These advisers would do well to remember that if they attempt too many changes in the Stevenson method of operation they might lose some of the punch of this fellow's much admired personality."

New York—Edgar H. Dixon, president of Mississippi Valley Generating Co., announcing plans to go to court to recover money it spent on the Dixon-Yates power plant before the project was called off by the government:

"The money we have spent and are trying to recover was spent with the full knowledge of the AEC. We will promptly file an appropriate action in the courts and are confident of the outcome."

Chicago—Janice Hullinger, 17, of Manly, Ia., on her pet steer which came down with pneumonia two days before the opening of the International Livestock Exposition in which she planned to enter him:

"Shorty's pretty sick but we haven't given up hope and maybe we can still enter him. He'll probably lose some of his finish but maybe we can get him well and fatten him up in time."

Castel Gandolfo, Italy—Pope Pius XII making a farewell public appearance at his summer villa in a comment to one American:

Washington—Herbert V. Prachnow, Chicago banker who recently joined the State Department, on word usage peculiar to diplomats:

"I have found that every discussion is 'substantive,' every job is an 'exercise' and there is no such thing as a one-page memorandum."

"The picture here shows a steady trend toward absolute control of the auto industry in the offices of General Motors."

Inval Mother Undisayed After Latest Misfortune

Washington, Pa.—(U.P.)—An in-

valid widow and six of her child-

ren spent a happy Thanksgiving

with relatives today, un-

dismayed at being homeless for

the second time in seven years

in the latest of a long series of

misfortunes.

Mrs. Blane Horner, 40, con-

fined to a wheelchair with

arthritis, at five of the six

children fled safely from their

home here Wednesday when fire

the one-story frame dwelling.

Not Going to Worry

"I'm just thankful no one was

hurt this time," she said at the

home of her sister, Mrs. Grace

White. "I'm not going to worry

about anything else . . . just as

long as my children are happy

today."

The fire came a little more

than seven years after two of

Mrs. Horner's 10 children were

burned to death when their

home at nearby Wolfdale was

gutted in October, 1948.

That was the beginning

of a long string of troubles for

the Horner family. A short time

later, another child died of

meningitis. Two years ago, Mrs.

Horner's husband, James, died

of cancer.

James Jr., 19, the oldest child,

became the family's sole means

of support by doing odd jobs and

working as a part-time farmer.

But recently he was inducted

into the armed forces and the

family was left in a state of

despair.

From her wheelchair, Mrs.

Horner saw it that her child-

ren got the best care her meager

income would allow.

Her niece, Gertrude White,

said "she never cared about her-

self. She was always looking out

for her youngsters."

But the Horners, with the ex-

ception of James Jr., were all to-

gether today for a big turkey

dinner in the Whites' home. Mrs.

Horner was far from unhappy.

She smiled and said, "It could

have been worse."

Idaho Couple Observes 80th Wedding Anniversary; Nation's Longest Married

Sagle, Ida.—(U.P.)—Mr. and Mrs. Benjamin Hartley offered a special prayer of thanks today as the one-time childhood sweethearts marked their 80th wedding anniversary to rule as the nation's longest-married couple.

The observance was a quiet one, tempered by concern over the illness of "Grandpa" Hartley whose failing health requires a 24-hour bedside vigil.

The oldsters, both 96, have been living here since 1937 at the home of their "baby" son, Leo, who is nearly 60. Another son, James, 76, helped celebrate the anniversary. Frank, the third living son, visited for several weeks this summer before returning to his home at Sattanta, Kan.

Well Satisfied

"I have plenty to be thankful for," said the sprightly Mrs. Hartley. "Eighty years is a long time, but I wouldn't trade a minute of it."

And that goes back to a chilly day in 1875 in London county, Tenn., when Ben rode up to Drusilla Keith's house, put his

sweetheart on his horse and rode off to Lenore City to be married. They were only 16, but they

Oakland, Calif.—(U.P.)—Burton W. Abbott ate his Thanksgiving Day turkey today with fellow prisoners in the Alameda County jail, his kidnap-murder trial in a long holiday recess.

At 3 p.m., Abbott was to sit down to a dinner consisting of turkey, giblet gravy, candied yams, cranberry sauce, peas and carrots and Waldorf salad.

Dessert was to follow at 6 p.m., when he was to have coffee and a choice or pumpkin or mince pie.

As for the rest of his family—his wife, Georgia, his mother, Elsie, and his brother, Mark—"No plans have been made," a family spokesman said.

The trial will resume Monday with further cross-examination of Berkeley Police Inspector Charles O'Meara, who headed the investigation into the disappearance of 14-year-old Stephanie Bryan last April 28.

Few Germans Blame Reds for Big 5 Failure

Weisbaden, Germany—(U.P.)—Less than half of the West German people place the blame on the Soviets for the failure of the Geneva Conference, a public opinion survey indicated today.

A poll of 1,000 Germans showed that 49 per cent blamed the Russians, 23 per cent blamed all of the Big Four powers and five per cent fixed the guilt on the Western powers.

Only 30 per cent of those questioned under 30 years of age thought the Russians were responsible for the conference failure.

San Salvador Observes First Thanksgiving

San Salvador—(U.P.)—Thanksgiving Day was observed in El Salvador today for the first time in the country's history.

The initiative to observe the American holiday came from Roman Catholic Archbishop Luis Chavez y Gonzalez. The Chamber of Commerce requested all business establishments to close before noon.

Taxation Has Many Problems, Hawver Tells Kiwanians

Taxation is a many faceted sort of a problem, Deputy County Assessor Andrew Hawver brought out yesterday in a talk to Medford Kiwanians concerning property reappraisal in Jackson county.

Mentioning that reappraisal provided the first opportunity in a number of decades for a full physical inventory of property values, Hawver pointed to a 30.6 per cent increase in taxable value for this year over last. Assessed valuation for 1955 was \$80,658,894.05 compared to \$61,764,115.32 in 1954, he reported.

However, last year's totals were based on a 1930 replacement cost factor while this year's valuation were figured from property values as determined by reappraisal started in the county in 1952. The new figures were not used until this year. Assessed valuation this year was determined at a ratio of 25 per cent of appraised value.

Average millage rate in the county dropped from 70.2 mills last year to 63.3 mills this year but taxes in dollars increased 14.4 per cent, \$4,631,498.39 to \$5,413,239.45.

Discussing why property taxes increase and continue to go up, Hawver stated that 84 cents out of every tax dollar, on a conservative average over the county, goes to the schools. He said that 59 cents out of the tax dollar in Medford, goes to the schools. Hawver also reported that value of property in the county exempt from taxes is \$42,620,310. "If some people don't pay, others have to pay for them," he remarked.

The deputy assessor, who answered questions after listing facts and figures, said that the people's own vote will determine whether there is a boost in taxes next year. He said that people are welcome to come to the assessors office and see the appraisal cards on their property.

The luncheon meeting was at the Jackson hotel.

Towns in Colombia Wiped Out by Flood

Bogota, Colombia — (U.P.) — Four towns on the banks of the Magdalena river were reported today to have been almost wiped out by flood waters of the big river, Colombia's chief inland waterway.

Guaimaro, Remolino, Salamina and Sitio Nuevo were said to have taken the brunt of the flood. Seventeen other towns in the lower reaches of the river were reported flooded. More than 15,000 persons were evacuated. There were no reports of casualties.

Symonds' Convicted Killer Makes Appeal

Singapore — (U.P.)—The court of criminal appeal heard today the appeal of Chinese truck driver Ang Ah Too, convicted and sentenced to death for the murder of United Press Correspondent Gene Symonds last May.

Symonds was fatally assaulted by a mob during a labor riot in Singapore May 12. He died in a hospital the following day as a result of head and body injuries.

About a month after the riot, Ang Ah Too and an Indian youth, S. Suppiah, were arrested and charged with Symonds' death. In the trial that followed, Suppiah was acquitted and released but the jury found the Chinese driver guilty of the charge of "being a member of an unlawful assembly, the common object of which was to cause hurt to one Gene D. Symonds and that while a member of that assembly, one or more members thereof committed murder by causing the death" of Symonds.

Soviet Journalists Return To Moscow

London — (U.P.)—A group of Soviet journalists returned to Moscow Wednesday night from a month-long tour of the United States which extended from New York to San Francisco and back again, Radio Moscow said today.

The broadcast said the Red newsmen "visited the editorial offices of the most important newspapers and publishing houses, met writers, artists and took part in television broadcasts," the broadcast added. It did not record any of the Russians' impressions.

A Radio Moscow broadcast earlier complained bitterly that the Russians had to cancel their trip to Chicago because "the State Department refused to be responsible for their safety."
