The court of appeals ruled that pretty blonde Dagmar Jeansson had a perfect right to marry 20-year-old Borje Magnusson despite the bitter opposition of the girl's parents. The ruling upsets a lower court decision in favor of margarine magnate Ragner Jeansson and his wife. But they still may appeal to the Supreme Court before the end of the year in a new effort to block the marriage. Without parental or court consent, Dagmar and her poor fiance would have to wait until both are 21.
