Flood Losses Are Tax Deductible, IRB Says

Washington (U.P.)—The Internal Revenue Bureau is issuing special pamphlets to flood-stricken California and Nevada today explaining what losses are deductible from income taxes and how to compute them.

The pamphlets were first issued for victims of this summer's disastrous New England floods. An Internal Revenue Bureau official disclosed last night that individual help in making out returns for flood sufferers will be given to the "fullest extent needed."
