Ford Foundation

Announces Grants

Ford Foundation announced today it
has made grants totaling \$2-
750,000 to five universities and
the Brookings Institution to sup-
port research professorships in
economics.

Under one phase of the pro-
gram, endowed professorships
will be established at the Uni-
versity of California, University
of Chicago, and at Yale, Colum-
bia and Harvard universities.

To facilitate their investiga-
tion of important economic prob-
lems, the foundation said, these
research professors also will be
provided with the necessary re-
search assistance and travel
funds.

The second phase of the pro-
gram to be administered by the
Brookings Institution, is design-
ed to aid research by economists
on the faculties of accredited
four-year liberal arts colleges.
