Springfield, Ore.—(U.P.)—Worshippers at the Springfield Lutheran church yesterday, interrupted in their hymn singing when a policeman rushed in to tell them the building was on fire, calmly marched outside still singing "He Leadeth Me," as the officer brought the small blaze under control.

Patrolman Robert Troutman said that he was cruising near the church when a motorist called his attention to smoke coming from the church.

He rushed to the fire with an extinguisher while the congregation fled from the church, and soon had the blaze quelled.

Firemen said that the blaze could have reached "disastrous" proportions if not seen when it was. It started in a blanket on a carpenter's sawhorse. Firemen said that it could have been caused by children playing with matches or by spontaneous combustion.

Greeks Rebuff Offer To Visit Russia

Athens, —(U.P.)—Greek government leaders handed Soviet Foreign Minister D'imitri T. Shepilov the first rebuff of his maiden diplomatic tour Saturday by refusing his invitation to visit Moscow.

Instead they reaffirmed their unity with the west. Greek Foreign Minister Evangelos Averoff said in a communique that a visit to Russia by himself and Premier Constantine Karamanlis would not be "constructive" at this time.

Averoff pointedly reaffirmed Greek support of the west and its obligations to the western community as a member of NATO.

The New York State Power Authority and the St. Lawrence Seaway development will open two shaded pavilions for spectators. One will provide soft drinks and both will be equipped with closed circuit television.
