Errorless Machine Turns Out Grades Knoxville, Tenn. — (U.P.) — Prof. Guy H. Parham of the University of Tennessee has designed a calculating machine that turns out grades for a university course in two hours and 20 minutes. Computing grade averages for the course now requires 50 man hours.

The complete computation for one student requires only 16 seconds, Parham said. Furthermore, the machine makes no errors.

The computer, about the size of a typewriter case, has 10 knobs on top, each with its own grade scale for a particular test or project, and a dial which reads the final grade either as an exact numerical grade or letter grade.

Famed Chimney Isle Sale Brings \$350 Ogdensburg, N. Y. — (U.P.) — Historic Chimney Island, where the French made their last stand in North America in 1760, has been sold for \$350.

The six-acre island was sold by the city of Ogdensburg to the state. It will be removed for St. Lawrence River seaway navigation.

Nearly 200 years ago, the island was the site of Fort de Levis, named after a famous Frenchman, Chevalier de Levis. On Aug. 26, 1760, 10,000 British troops and 800 Indians led by Lord Jeffrey Amherst, captured the island fortress from the 300 French defenders after a bombardment and week-long siege.

The British renamed it Fort William Augustus. During the Revolutionary War it was a rendezvous for scalping parties of the Tory-Indians.
