

Ike Asks Bulganin To Withdraw Troops

Washington—(AP)—President Eisenhower has called on Soviet Premier Nikhita S. Bulganin in a personal message to withdraw Russian troops from war-torn Hungary. He asked Bulganin to let the Hungarians choose their own government.

Mr. Eisenhower sent the urgent message to the Soviet Premier Sunday after conferring at the White House with Acting Secretary of State Herbert Hoover Jr. and Allen Dulles, head of the Central Intelligence Agency.

The message also presumably dealt with the Middle East crisis. The text of the President's message to Bulganin will not be made public until the United States and Russia reach agreement on publicizing its contents.
