Domiciliary Manager Addresses Roundtable

E. K. Ricker, manager of the veterans administration at Camp White, disclosed the organization and development of the domiciliary at the noon luncheon meeting of the Jackson County Chamber of Commerce Round Table yesterday at the Jackson hotel.

There are presently 880 beds at the domiciliary, he said, and there is potential space for as many as 2,000 beds. By the first of the year there will be over 1,000 beds there, he added.

Ricker explained that the domiciliary furnishes a "home" for the veterans as well as medical treatment, food and entertainment. Daily cost per member, he said, is \$5.

Per annum cost of running Camp White, he said, is over \$1,600,000. Payroll which Camp White extends to its domiciliary members amounts to over \$1,200,000 annually, he said. Most of this money, Ricker pointed out, is spent on medical care.

Camp White is also renovating its theater, he said, at a cost of \$40,000 to install a new stage. He added that Camp White also has money for a picnic grounds and a pitch and putt golf course, which will soon be installed.

March of Dimes Picks Poster Girl for 1957

New York—U.P.—Little blue-eyed Marlene Olsen, who plays "polio hospital" at home while other children run in the sun, has been named 1957 March of Dimes poster girl.

"The first question I ask every parent I meet is: 'Have your children been vaccinated against polio?'" her father, Air Force Capt. Arnold Olsen, a holder of the Distinguished Flying Cross and a Korean war veteran, has said.

At the top of the poster is the slogan "Remember Me" which the National Foundation for Infantile Paralysis said is a reminder of the unfinished job to be done in the spirit of the Salk vaccine.
