All Captains Picked For Mothers' March On Polio January 31

Captains for all of Medford's 14 districts in the Mothers' March on Polio, scheduled for Jan. 31 between 7 and 8 p.m., have been named, it has been announced by Mrs. Gene Neff, Medford Mothers' March chairman.

At a recent meeting of her captains, Mrs. Neff explained the urgent need for March of Dimes funds and warned her workers that "while polio is on the run, it is not yet conquered."

Districts Divided

Captains have divided their districts into sub-districts and named a lieutenant for each. The lieutenants in turn will appoint block workers who will call at each house in their assigned area during the one hour.

Mrs. Neff said that a card on which the householder may keep records of his family's Salk anti-polio shots will be left at every home in the city. Householders desiring to make a contribution to the March of Dimes may indicate their desires by a lighted porch light, Mrs. Neff said.
