By UNITED PRESS Chicago—American Medical Association President Dr. Dwight H. Murray, urging the public "especially those under 40" take advantage of available Salk polio vaccine: "It seems that society now is the patient most in need of medical attention." Washington—Former President Truman, suggesting that Congress should "spell out in some degree" guides for the exercise of the authority it will probably grant the President under the Middle East doctrine: "Far from being a hindrance to the administration, in the present state of confusion, such a recommendation should help fill the void of policy." Washington—Sen. Hubert H. Humphrey (D-Minn.) questioning Secretary of State John Foster Dulles on how much aid oil-rich King Saud of Arabia will get under the Eisenhower Doctrine: "How much are you going to give King Saud. Cincinnati—United Steelworkers President David J. McDonald warning racketeers against trying to gain control of the union or their fund and workers against collaborating with racketeers: "If any of our people fool with racketeers, by the eternal God, they and the racketeers will go to jail." Memphis, Tenn.—Safe cracker Alfred James White, one of the newest names on the FBI's "10 most wanted" list, describing the life of a fugitive after he was apprehended: "You ought to try it just one night. I didn't dare talk to anyone. I went to a lot of picture shows, and I went often to the airport and just sat and watched the planes come in." Hollywood—Actor Michael O'Shea, husband of film star Virginia Mayo, admitting firing a rifle at the tires of a tractor driven by a neighbor's son who he said raced hot rods on the adjacent property and endangered his three-year-old daughter: "I called police several times and no action was taken. Grace's Daughter Officially Heiress

Monaco—U.P.—Two-day-old Princess Caroline Louise Marguerite officially became heiress-presumptive today to the lands of Europe's oldest ruling royal family. She will succeed to the throne of Monaco unless a brother is born. The name of the daughter of Princess Grace and Prince Rainier was inscribed in the gold-trimmed register of the Grimaldi family, a clan which has, with two exceptions, ruled this 368-acre principality since 1297. The ceremony was held in the green room of the Grimaldi family's stone-walled palace overlooking the Mediterranean. Princess Caroline's legal position in line of succession was witnessed by the president of the Monaco State Council, who acted in his capacity as director of Monaco's judicial services. Dr. Emile Hervet, Princess Grace's chief physician, said Thursday both mother and daughter were in "excellent condition."

Heavy Snow Makes Driving Hazardous

Construction at SOC Expected to Start This Fall

Ashland—Construction of two more major buildings at Southern Oregon college is expected to get under way by early fall, Dr. Elmo N. Stevenson, SOC president, has announced. The two new buildings are a men's dormitory and a commons, which will be the dining hall for all campus dormitories. Estimated cost of the proposed buildings is \$640,000, of which \$420,000 is for the dormitory and \$220,000 for the commons. Preliminary Plans Preliminary working plans will be submitted to the state board in March with final plans for approval about July 22. Dr. Stevenson said he anticipated construction will be started this fall. The schedule calls for completion of both buildings by the fall of 1938. Both projects are self-financing with income from the buildings and fees. The state board also approved the purchase of two and one half acres from Sam Tooley for the campus. The board also approved an advance of federal funds of \$3,500 for planning of a new science building. Approval was also given SOC to acceptance of the Amalia Britt gift to the college, which has an estimated value of \$162,000, including cash, notes, real estate and historical items. Funds from the Britt gift are being used in the reconstruction of Memorial court into the Britt student union.

Four Questioned in Abduction of Girl

Portland—U.P.—Police today questioned four young men in connection with the abduction and robbing of a 17-year-old girl last night. Patricia H. Turner told police that a car with four occupants followed her when she left her job at St. Vincents hospital about 9 p.m. She said one man asked her if she wanted a ride. Finally, she said, one of the occupants got out, clamped a hand over her mouth and dragged her into the vehicle. She said she was constantly threatened and that one man scratched her upper lip with a knife. A citizen noticed her struggles and followed the car, obtaining the license number before he lost sight of the vehicle. Miss Turner said she was driven east of here and robbed of \$18 and then brought back to Portland where she was released. Detective Sgt. Dan Mitola said the four young men were picked up later. Police withheld their names until they finished questioning them.

Trustees of State Library, Committee Discuss Legislation

Trustees of the Oregon State library met with the Oregon Library association's library development committee in Salem Jan. 19 to discuss a bill which the state library board plans to introduce during the present session of the state legislature. The chief aim of the bill is to improve library services in Oregon to residents of rural areas and to towns of less than 10,000 population, according to library officials. The bill provides for funds from the state to match federal funds which are expected to be available as the result of the federal library service act signed by President Eisenhower last spring. Both state and federal funds will be available for a five-year period only and will be used to demonstrate the value of library service in areas where such service can later be supported locally. Assume Leadership Mrs. Warren McMinimnee, of the state library board, reported that the board will assume leadership in the promotion of the legislation which it is sponsoring. Members of the library development committee will take the responsibility of stimulating action at local levels, by the people who have expressed a need for rural library service and will benefit directly from it. Plans were announced by Mrs. Mabel E. Baker, of the Oregon State Library, for the purchase of two bookmobiles to be bought and stocked by the state library and routed throughout the state in a demonstration of mobile rural library service. A tentative schedule provides for the use of the bookmobile in Josephine county in late April and in Jackson county during the fourth week of April and the first week of May. Plans for the joint use of a bookmobile either by Ashland Public Library and the Jackson County Library or by Jackson and Josephine counties together are under consideration if state and federal funds come available. Jackson county librarians who attended the Salem meeting were the Misses Cora Mason and Helen Webster.

Board Recommends Teacher Wage Boost

Rural school board members of Jackson county Tuesday night agreed to recommend the Jackson County Rural School board grant a \$200 annual across-the-board salary increase for the county's rural teachers. The proposed increase would be in addition to the salary raises already assured for teachers by the county rural board. Also proposed at the meeting was a \$350 to \$400 increase for teachers and superintendents. This was discarded by a formal vote as was a \$100 a year increase proposal. The \$200 annual raise was approved by a 9-4 vote. Superintendents would not be included in this proposed raise.

Prisoners Escorted to State Penitentiary

Joe Walsh, chief deputy sheriff, today escorted two prisoners to the state penitentiary where they will begin sentences imposed in circuit court here. Roy Gene Privratsky, 21, Seattle, Wash., was sentenced to two years and six months on a charge of robbery not armed with a dangerous weapon.
