Egyptians Look to Aswan Dam With Much Interest

(Editor's note: Marion D. Thomas, extension agricultural economist at Oregon State college discusses Egypt's Aswan dam and its relation to the economy of Egypt in the following article. It was written in connection with the "Great Decisions... 1957" program, which is now under way in several Oregon counties, including Jackson county.)

Even so, we probably took little notice last summer when the U.S. government withdrew an earlier offer of loans to help Egypt build a big dam on the Nile river. To the Egyptians, their great Aswan dam seemed likely to mean more than our Bonneville and Grand Coulee mean to us. They expected their dam to increase arable land by 30 per cent, electric power by 800 per cent, and national income by 33 per cent.

More People The Egyptians have only a little more cropland than Oregon, but have more than ten times as many people. It's easy to see that our government's action could have been a keen disappointment to them. Within a week of the U.S. decision, the Egyptian government took possession of the Suez canal, through which nearly 15,000 ships passed in 1953. They said profits from operating the canal would finance the dam. Would they have taken possession anyway? It's doubtful that anyone outside Egypt knows for sure.

We know what happened since. We know that, after bombing and sabotage, the canal is unusable for several months. It is not yielding the tolls Egypt sought, and that tensions between the Arab and Western countries have greatly increased. Higher Oil Prices We know that our gasoline and oil prices are higher. This is due in part, we are told, to our efforts to make up Europe's loss of Middle East oil to keep

We are alarmed because we recognize that difficulties in the Middle East could lead to full-scale war. We realize that this threat is added to the cost of containing Russia and protecting our way of life from the Communist threat.

And we are not sure what we can or should do about it. Yet, in order to maintain its position of respect and world leadership, the U.S. must take a position and set a course.
