Substitute Stopped Industrial Averages From Setting Record

By ELMER C. WALZER
United Press Financial Editor
New York—The stock
market all but made a record
high on July 12 when the in-
dustrial average came within
0.28 points of its peak set on
April 6, 1956.

And it would have gone
through to a new record
with a bang had it not been
for the fact that Dow-Jones substituted
International Paper for Loew's on
July 3, 1956.

That fact was brought out to-
day in Investor's Reader, pub-
lication of the brokerage firm
of Merrill Lynch, Pierce, Fenner
& Beane.

The magazine notes that
Loew's has eased only 2 points
since the Dow-Jones average hit
its 1956 high. International Pa-
per has fallen 28 points since then.

"Had the switch not been
made or had the timing been
different," says Investor's Read-
er, "the entire Dow-Jones in-
dustrial would have been nearly
five points higher and thus
would have smashed to a deci-
sive new all-time peak in mid-
July."

New Bull Phase

would that have made a differ-
ence in the market's perform-
