

Trujillo Jr. Gets Rank of General

Cuicled Trujillo, Dominican Republic—(UPI)—The promotion of Rafael Trujillo Jr., 29, to the rank of full general in the Dominican Republic's army and air force has been announced by his father, Generalissimo Rafael Trujillo.

The promotion presumably was the result of the appointment by his father of young Trujillo to the newly-created post of chairman of the Dominican joint chiefs of staff.

Young Trujillo's appointment to the state post was announced the same day the U.S. Army announced he had flunked out of its general staff and command school at Fort Leavenworth, Kan. The Army announced last Friday that Trujillo Jr. would receive only a certificate of attendance because he "did not successfully complete the course."

Trujillo Jr. previously was commander of the Air Force with the rank of lieutenant general. He currently is in Los Angeles, Calif.

New Packaging Plan Featured in Article

A new lumber packaging plan is explained by George C. McCracken, manager of the Lumber Co. company in the June 11 issue of Crow's Lumberman.

McCracken, a Medford resident, is chairman of the subcommittee on lumber handling and shipment, National Lumber Manufacturers' association. He discusses how the McCracken plan "eliminates shortages and claims for damage in transit, minimizes grade, and improves the appearance of the lumber by presenting it in a trim, uniform, neatly-bound package."

The McCracken plan calls for packaging lumber in packages 10 by 24 inches by varying lengths and 12 by 20 inches by varying lengths. He points out that with these dimensions, every package has 20 board feet of lumber per lineal foot.

The packaging reduces handling problems by doing away with the piece by piece handling prevalent since the industry began.

Sealed proposals for the construction of a Sanitary Sewer System in the Kenwood-Grandview area, addressed to the Mayor and City Council, Medford, Oregon, will be received at the City Recorder, City Hall, Medford, Oregon, until 11:00 a.m. Pacific Standard Time on the 11th day of July, 1958, and then will be publicly opened at 2:00 p.m. of the same day.

The work contemplated consists of construction of approximately 1,000 lineal feet of 24-inch diameter concrete rubber-ring type sewer pipe and 8- to 16-inch asbestos-cement pipe, together with necessary manholes and other appurtenances. Approximately 8,300 cubic yards of earth will be excavated, using either concrete rubber-ring or asbestos-cement pipe, as is included.

Proposals will be received on two bids, each consisting of a portion of the sanitary sewer system. The work will be awarded to the bidder or bidders in the opinion of the City Council, will best serve the interests of the City of Medford.
