Editor's note: The Family Council consists of a judge, a psychiatrist, three clergymen, a newspaper editor, a women's editor and two writers. Each article is a summary of an actual report. The Family Council does not give advice; it merely reports on problems that have been dealt with by responsible agencies and counselors.

Lucille M. — She should take this chance.
Nora T. — I'm not ready for such a drastic step.

Lucille M. — My friend and I are career women in our mid-40s. Nora was married once before — very unhappily. She never intended to marry again.

Recently she met a very interesting man in business. They went out together and had wonderful times. Nora told me that she felt for the first time in her life that she was really in love. Then Frank broke the news — that he was so financially ruined by his first marriage, paying support to his ex-wife and children, he could never consider marriage again. But he told Nora he loves her and will give her affection and loyalty if she will live with him outside of the marriage bonds.

Frankly, I don't see why Nora should hesitate to take whatever happiness she can find. I am not an immoral

person. But I know what loneliness is. It can't be wrong to give and receive happiness without hurting anyone else.

Nora T. — I think if I were in Lucille's place I might give the same advice she gives, yet when actually confronted with the idea I am not so ready to take a drastic step of this kind. Until I met Frank I was so lonely and hungry for masculine attention, I thought I would jump at the chance of crumbs of affection, but now I feel I want much more.

On the other hand, the thought of losing Frank is terrible to me. I have become accustomed to the fun of going out with him and having a man to share things with. I know I won't be able to keep his company much longer on this basis because he is determined to have an intimate relationship outside of marriage.

I would be willing to continue working for some time after marriage and I told Frank so. But if I were married I would eventually want to give up my job. Frank says he can't see how we could make a go of it.

The Council: Lucille is enough removed from this situation to be able to see it through a romantic haze. From a safely aloof position, she fantasizes she would leap at the opportunity for some brand of what she likes to think of as love.

But if she were as close to the situation as Nora is, she would be able to see what is being offered here is an obvious phony. Any individual — man or woman — knows when real love is offered there is a way of getting around obstacles. When one has genuine feeling for another, one wants it to live and grow within the context of a binding, meaningful tie.

This tie is certainly not less meaningful among mature persons than among younger ones. Younger persons with little experience of life may simply accept existing moral standards because they are taught that such and such is right. Older persons may question the standards, but if they question deeply enough they can't help but see the truth and justice behind the standards.

We don't think Nora will find her way out of loneliness by accepting an affair with Frank, but neither do we think she must therefore doom herself to continued loneliness. If she examines her way of life, Nora will undoubtedly find that she has cut herself off from many interesting opportunities for fine friendships with men and women.

Probably her fear of being burned again after an unhappy first marriage has damaged Nora's relationships with others. If she will try to put that fear behind her, she may find herself entering a period of enriched relationships that do not call for "drastic steps" that violate her common sense and underlying standards.
