

Oregon Highway Commission Opens Bids on Projects

Salem (UPI)—Bids on about \$5 million in highway projects were opened by the State Highway Commission here Tuesday.

State Highway Engineer W. C. Williams said the bids were about 15 per cent under engineering estimates overall.

Rogers Construction Company, Portland, was apparent low bidder on the largest project, bidding \$1,658,362 for 9.26 miles of grading on the Old Oregon Trail highway about 18 miles east of Pendleton.

Roy L. Houck, Salem, was apparent low at \$686,428 for 6.70 miles of grading on The Dalles - California highway southeast of The Dalles.

Other low bidders on other projects included:

Baker Pacific Concrete Company, Portland, \$48,949 for a 170-foot concrete bridge at Eagle Creek just south of Richland.

Clackamas: Serg R. Perrin, Oregon City, \$9,140 for a sand storage shed at Sandy.

Cos: Sig Anderson, Cos Bay, \$48,935 for Fairview bridge over the north fork of the Coquille river about 7 miles northeast of Coquille.

Cos: Townbridge Electric, Roseburg, \$3,600 for traffic signal installation on Cape Arago highway in Empire.

Deschutes: Mann Construction Company, Redmond, \$30,969 for Deschutes river bridge on Century drive highway about 16 miles southeast of Bend.
