IN THE NAME OF THE STATE OF OREGON, You and each of you, are hereby required to appear and answer the Complaint filed against you in the above entitled suit on or before the last day of four weeks from the first publication of this summons, and if you fail to so appear and answer said complaint, for want thereof, the Plaintiff will apply to the Court for the relief demanded in her Complaint, succinctly stated as follows, to-wit:

That a decree be entered adjudging you and all right, title, estate, lien or claim which you or any of you have in, to, upon the real property described as follows, to-wit: East Half of Lot Six (6), in Block Three (3), Rogue Valley Heights Extension, according to the official plat thereof, on record of record.

and decreeing that it is due, owing and wholly unpaid the principal sum of \$1,233.32, together with interest thereon at the rate of 6% per annum from the 15th day of May, 1955, until paid; and awarding to Plaintiff a judgment against the Defendants in the sum of \$150.00 as attorney's fees for the prosecution of this suit, together with Plaintiff's costs and disbursements herein to be taxed, that all the right, title and interest of the Defendants herein and all persons claiming by, through or under them, or any of them, in and to the property agreed to be sold under the agreement of sale returned to in said complaint, be foreclosed and wholly terminated, save only the right of redemption as hereinafter stated; that the Plaintiff be entitled to immediate possession of said real property; that said right of possession shall be continuous during the period of redemption; that the Defendants may redeem said property within (30) days from the date of entry of said decree or within such time and such time as the Court may find and determine to be sufficient and equitable, by paying to the Plaintiff the amount owing and unpaid from the Defendants, and the Plaintiff and Plaintiff's attorneys, as aforesaid, together with the attorney's fees to be awarded to Plaintiff, and together with interest thereon from the date of such decree at the rate of 6% per annum from the date of such payment; and for such other and further relief as to the Court may seem just and equitable in the premises.
