Parris Island, S.C.—The first of three Marines charged with taking money from recruits and mistreating them faced a general court martial today.

Sgt. Ralph A. J. Grant, of Racine, Wis., is charged with accepting money from members of an Ohio platoon which finished basic training at the post last September.

Members of the platoon charged that Grant and Sgt. Willard B. Poss of Augusta, Ga., accepted \$690, each man contributing \$10.

Grant, Poss and Sgt. Donald J. Heller of Milwaukee, Wis., all are charged with assaulting recruits under their command.
