

Hammarhjold To Visit in Moscow

United Nations, N.Y. — (UPI) — Informant United Nations sources said Wednesday Secretary General Dag Hammarskjold has decided to visit Moscow in hopes his own "quiet diplomacy" might prevent a major crisis over Berlin.

Hammarskjold let it be known several weeks ago he planned a trip to Southeast Asia, specifically to Cambodia, whose border troubles with Thailand have highlighted resurgent Communist activity in Southeast Asia.

Tuesday it was disclosed he would add Moscow to his itinerary just as the Berlin situation appeared to be getting hotter. Informants said it was hardly happenstance that was taking him to the Soviet capital.
