

Many Suicides Declared Caused By Relatives

Chicago, (Science Service)—Some suicides are actually victims of a "psychic murderer."

The "murderer" might be the victim's relative or close friend, Dr. Joost A. M. Meerloo, a New York psychiatrist, indicated.

Psychiatrists agree that punishment of parents, spouses or bosses is one of the most frequent causes of suicide. This can be considered a form of mental blackmailing, the psychiatrist stated in the Archives of Neurology and Psychiatry. It is as if the suicide said, "you'll be sorry when I'm gone."

But many other people commit suicide because they are literally driven to it by someone with whom they identify themselves. These persons are the victims of "psychic murder" that is committed by friends or relatives.

Aware of Wish
They commit suicide because they are aware of the wish or command of the "murderer" that they had to die, though this homicidal verdict has seldom been verbalized in a conscious way, the psychiatrist explained.

The burden of inadvertent hostility and murderous wishes can push these persons with weak egos into depression resulting in suicide.

"Especially in suicide by children," the author said, "we realize how much rejection, teasing and vituperation have to do with loss of self-esteem, and how these humiliations can drive a young person to suicide."

Dr. Meerloo related his concept of psychic homicide to that of brainwashing in which the person is made by another to believe, say and do things that he himself would not ordinarily do.
