

Wall Street Chatter

New York — (UPI) — Noting that the market to date is only 1.4 per cent above the 1958 year-end level, compared with a 38.1 per cent rise in the year-ago period, Standard & Poor's says it regards the slowdown in the nature of a breathing spell.

Edmund W. Tabbell of Watson & Co. mentions as "good values" Northrop Corp., apparently being overlooked in the search for missile and electronic stocks although nearly 70 per cent of its business comes from these and re-

lated products; Wilson & Co., whose earnings are estimated at a possible \$4.50 a share for the fiscal year ended Oct. 31, 1959 compared with \$3.10 in 1958.

Over-subscription of the Treasury's \$500 million offer of 10-year, 4 per cent bonds, according to International Statistical Bureau, suggests some investors may be turning to bonds instead of common stocks.

Investors Advisory Institute, discussing the giant over-the-counter market as a medium for profitable investment, recommends ten unlisted issues which it feels have "better" than average appreciation potential: Diebold, Electronic Associates, Fisher Governor, Hagan Chemicals, Interstate Motor Freight, Jerold Electronics, Kaman Aircraft and Polymer Corp.
