Livestock in Fair Spotlight

Beef and sheep take the spotlight in the Jackson county 4-H and FFA fair tomorrow at the fairgrounds. As estimated 430 head of livestock will be shown by their young owners and handlers in both 4-H and FFA classes. The three FFA chapters of Crater at Central Point, Phoenix, and Eagle Point will enter the competition rings first since they have the smallest number of entries.

Tuesday's events get under way with swine and sheep weighing at 6 a.m. at the fair grounds. Swine events will be held Thursday. The 4-H girls will have their home economics exhibit judging at 8 a.m. The livestock judging contest follows at 8:30 a.m. The beef fitting contest will be held at 10 a.m., wool judging and beef showmanship at 1 p.m. and beef showmanship championship at 7 p.m.

The beef contests will probably be the most colorful events of the fair with the large Herefords and Angus almost dwarfing their owners as they parade them around the show rings. Both 4-H and FFA members have been schooled on how to prepare and display their animals.

Preparation of stock for the show ring will be demonstrated in the beef fitting contest. The fine points of showmanship or handling of stock in the show ring will be tested by the judges as they watch the stock paraded before them, then carefully worked into standing positions.

Both 4-H and FFA members will also demonstrate how well they know what makes good beef and wool animals.

Festival Attendance Is Over Last Year

Ashland—Attendance for the first 20 performances at the Oregon Shakespearean Festival is 34,500 persons ahead of a year ago, Festival officials report. The Festival has played to 17,174 persons so far this season.

Forest Fire Suppressed After Burning Home

A forest fire which had serious potential was suppressed Saturday evening about 1 1/2 miles below the Methodist church camp at Dead Indian Soda springs. The Rogue River National forest office here reported that the fire broke out about 5 p.m. and burned a summer home owned by A. A. Guches, Thomas rd. The blaze spotted across Little Butte creek setting fire to the woods on the south side of the creek. A large group of men from a Methodist Laymen's camp, federal forest service personnel and one state department of forestry crew fought the fire. An aerial borate drop about one hour after the fire broke out is credited with doing much to control the blaze

Six Meet Accidental Death During Week End

By United Press International At least six persons met death in Oregon week end auto accidents and drownings. In addition a Salem woman was killed in an accident near Chehalis, Wash.

Lawrence, 8, of Joseph, died in a hospital Sunday from injuries suffered Saturday evening when he was struck by a car while riding a bicycle a mile east of Joseph.

Estacada Couple Killed John Turnbull, 53, and his wife, Emily, 50, of Estacada, were killed Saturday night when a foreign-made car plunged off the Clackamas river road about 16 miles east of Estacada. The auto rolled down a 350-foot embankment and came to rest at the edge of the Clackamas river. Both victims were thrown from the vehicle.

Mrs. James Lloyd Norman, 61, Myrtle Creek, was injured fatally Sunday in a collision between a pickup truck and car a mile south of Myrtle Creek. Her husband and Robert O'Connor, 18, and Ronald Hartman, 21, both of Myrtle Creek, were injured.

Donald McDowell, 18, Portland, was lost Saturday on an outboard motorboat turned over near the mouth of the Columbia river.

Bundy Found in Lake The body of George Hillen, 45, Redmond, was recovered Sunday from Paulina lake about 40 miles south of Bend. He drowned late Saturday when a boat overturned.

Anna E. Jones, 42, Salem, was killed when the car her husband was driving crashed against a concrete pole on a Highway 99 overpass six miles south of Chehalis, Wash. Her husband was injured critically.

The Coast Guard reported Sunday that the body of Fred Bennett, 63, Viking, Alta., was found 5 1/2 miles from the mouth of the Umpqua river on the southern Oregon coast. He was lost July 19 when a boat capsized. Also lost in the accident was Dr. Arthur T. Trenholm of Gresham, whose body was recovered then.

Oregon Centennial Coordinator Quits Portland—UPI—Ted Hallock announced today his resignation, effective Wednesday, as state coordinator of the Oregon Centennial. The job pays \$12,000 a year.

Drinking Crackdown Crowds Marion Jail Salem—UPI—Salem city jail was crowded with more than 60 persons after a week end crackdown on drinking in a downtown park called Marion Square.

Crater Lake Highway Another road section coming under this same program is the proposed re-alignment for the Crater Lake highway section from Prospect west toward Trail. Estimated cost for taking out major curves and widening the highway is \$700,000.

Third Major Fire In Cave Junction Destroys Cafe

Cave Junction—The third major fire to strike here in the last three months "completely gutted" Newman's cafe yesterday morning, according to reports, and caused an estimated \$20,000 in damages.

Jack Newman, owner, collapsed during the course of the fire and is under medical care today. He is reported to have had heart trouble in 1948.

The Cabax mill here burned on July 26, also a Sunday, and on May 14 the Chit Chat cafe and cocktail lounge burned.

Yesterday's fire broke out shortly after 4 a.m., in the kitchen of the cafe. Earlier, Newman had extinguished a fire in an oven which began when some bacon grease was spilled.

Shortly afterward he noticed a fire in the ceiling of the cafe. He attempted to put it out with a fire extinguisher but was unable to. He then went outside the cafe to phone the fire department, and collapsed.

The fire finally was reported to the Illinois Valley fire department by Norma Fay Spencer and by Mr. and Mrs. John Tillery.

Fairview Home Superintendent Dies

Salem—UPI—Dr. Irvin B. Hill, 44, superintendent of Fairview home for the mentally retarded here since 1946, died today.

Dr. Hill, who had been seriously ill last year, lapsed into a coma while visiting his parents, State Rep. and Mrs. Earl Hill of Cushman. He died in an ambulance en route to Salem about 5 a.m.

Dr. D. L. Callicrate, assistant superintendent, will take over the superintendent's job for the time being.

Dr. Callicrate said death was due to an acute asthmatic attack complicated by heart damage suffered in Dr. Hill's recent illness.

Flags were lowered to half mast at state institutions in his honor.

Survivors include his widow, Evelyn; sons Robert, 18, Richard, 16, and Douglas, 14, and his parents. Funeral arrangements were pending.

Senate Calls for Labor Bill Conference

Adm. 'Bull' Halsey Succumbs in Sleep

Fishers Island, N.Y. — (UPI) Fleet Adm. William F. (Bull) Halsey, 76, commander of the Third Fleet in the Pacific during World War II and leader of America's first offensive move after Pearl Harbor, died Sunday in his sleep.

The implacable fighter who had carried his attacks to the Japanese homeland by the end of the war was pronounced dead by a coronary occlusion at 11:45 a.m. (e.d.t.)

Arrangements Pending His body was flown to New York city from this small island off the Connecticut coast where he was vacationing, and was to be taken to Washington today. Final funeral arrangements, however, were delayed pending arrival of his family at the nation's capital.

President Eisenhower, in a statement released at Gettysburg, Pa., said he had lost "a personal friend" and "all Americans have lost one of their great national leaders."

"His great personal contribution to the successful campaigns in the Pacific and the exploits of the forces under his command are a brilliant part of American military history," the President said.

It was Bull Halsey who vowed while the war was raging that he would ride the emperor's white horse through the streets of Tokyo. He did not keep that promise, but he did push the war to the emperor's doorstep, attack in Tokyo, Honshu and Hokkaido and ranging up and down the Japanese coast in July and August, 1945.

Wife Survives Halsey married the former Frances Cooke Candy in 1909. She survives him, as do his son, William F. Halsey III, his daughter, Mrs. Margaret Halsey Spruance, and six grandchildren.

Columbo, Mo.—UPI—Eleven persons, including six children, were killed Sunday night in a three-car collision eight miles east of here.

Eight other persons were injured. They were admitted to Boone County hospital.

Officials worked during the night to identify the bodies, most of which were mangled beyond recognition.

Four of the dead were identified by relatives as Billy J. Eddy, 27; his parents, Gus Eddy, 59, and Mrs. Helen Eddy, 54, and a niece, Rae Denise Eddy, 4, all of White Hall, Ill.

Two women were tentatively identified as Mrs. Jessie Thompson and her mother-in-law of Richmond, Mo.

The other unidentified victims, including four children, were believed to be related to Mrs. Thompson. Relatives were en route from Richmond to assist authorities in identification.

Highway patrolmen said the accident occurred when one car swerved off the shoulder of the road. It skidded back on the highway and into the path of an oncoming car in which the Thompsons were riding. Moments later a third car, from Pine Grove, Mo., following the Thompsons, crashed into the wreckage.

Police said that it was not known how fast the first two cars were going. The third car apparently was not traveling very fast, however, because the occupants were only shaken up.

Castro En Route To Chile Conference

Santiago, Chile — (UPI) — Raul Castro and a band of Cuban revolutionaries were flying here today to "rescue" the Cuban foreign minister and to present proof that the Dominican Republic was trying to overthrow the Cuban government.

However, Castro got only as far as Lima, Peru, today and decided to remain there overnight, continuing on to Santiago Tuesday.

The conference itself met this morning as a general committee to begin final discussion of the resolutions designed to cool off Caribbean tempers and encourage democratic growth and economic cooperation in the area.

Heated Wrangle Ends in Move To Seek Compromise

Republicans Seek Vote Assurance

Washington—UPI—The Senate agreed after a long and heated wrangle today to send the tough House labor bill to a congressional conference committee to see if a compromise with the milder Senate version can be worked out.

Republican senators who favor the House bill did not press a move, favored by some, to bypass the joint House-Senate conference and force an immediate showdown on the Senate floor.

But they kept the Senate tied up for more than two hours while they sought assurances from Democratic leaders that they would have an opportunity to vote on the House bill later if the conference became deadlocked.

The action to send the bill to conference was approved with only a scattering of "noes" heard.

Mundt Chief Objector Sen. Karl E. Mundt (R-S.D.), vice chairman of the Senate Rackets Committee, was chief spokesman for the opposing conference group although he never formally offered a motion to bypass it.

He said he was not trying to block the conference but only to prevent the "Unhappy eventuality" that the Senate would never have an opportunity to vote for a measure stronger than the Kennedy-Ervin bill approved by the Senate.

He expressed fear the conferees either would weaken the house-passed Landrum-Griffin bill or would reach a stalemate.

Sen. Barry Goldwater (R-Ariz.), who will be ranking Republican Senate conferee, served notice that he will move to discharge the conference if there is no progress within seven days.

School Addition Bids to be Received

Ashland—Bids for the construction of an addition to the Bellevue elementary school will be received until 6 p.m., Aug. 31. Six classrooms, two bathrooms and a kitchen will be included in the addition.

Plans may be obtained at the Medford office of James L. Payne, Salem architect.

Specifications call for frame construction, with a concrete slab floor in the kitchen and wood frame floors in the classroom areas. Walls are to be plastered and the ceilings acoustically plastered.

Glued laminated beams will support a two-inch roof deck and sash will be aluminum.

Bids will be opened at the district's administration office, 885 Siskiyou blvd.

Orleans Forest Fire Uncontrolled

Orleans, Calif.—UPI—The Orleans forest fire, which has destroyed 2,000 acres of timber and caused an estimated \$250,000 damage, was still out of control today.

The U. S. forest service feared the fire, raging in northeastern Humboldt county in the Six Rivers National forest, would destroy 5,000 acres before it is stopped.

More than 750 men were on the fire line today and were holding 13 miles of the line under control.

Damage from the blaze was listed as \$192,000 in timber, \$55,000 in water sheds and \$1,000 in miscellaneous destruction.
