

## New-Fangled Home Tool Power Mower, Dangerous

Chicago - (UP) - A Florida woman was killed when a steel blade sailed 50 feet through a window pane and struck her.

A little girl died when her jugular vein was severed by a flying piece of metal.

A veteran of three World War II invasions was hospitalized when he was wounded by a flying kitchen spoon in his own front yard.

These three people were victims of one of the most common of the new-fangled home tools—the power mower.

In 1958, an estimated 15 million power mowers were in use, according to the National Safety Council. While no national statistics are available, a study in Georgia turned up the following facts:

1. Three out of 10 persons injured in power mishaps were hurt by objects thrown by the mower.
2. One injury in seven resulted in some permanent disability.
3. Toes and feet were parts of the body most often injured.
4. More than nine-tenths of the accidents involved rotary type mowers. The Council believes this is due at least in part to the great number of such mowers in use.

The power mower is no more dangerous than any other home tool, the Council said, if properly used and if a few basic rules are observed. For example:

- Don't use an electric mower when the grass is wet and slippery.
- Never allow youngsters or pets near a power mower. Never let a youngster operate one.
- Make sure the area to be mowed is free of sticks, stones, wire and other obstacles.
- Shut off the mower before moving it from one level to another or when you're working on it. Never leave the

Toledo, Ohio - (UP) - Was Warren Gamaliel Bancroft Winnipeg Harding the failure that history and hearsay have made him out to be?

Randolph C. Downes a professor of history at Toledo University, is dedicated to proving that he was not.

The professor believes that Harding, 29th President of the United States and himself a one-time newspaperman, was victimized by the sensational journalists of the 1920s.

Downes is writing a book to be published in connection with the 100th anniversary of Harding's birth in 1865. The professor said he has no intention of white-washing Harding but merely to put on the record "an honest appraisal."

Associated With Scandals  
To today's schoolboys, Harding is associated - if he is thought of at all - with the Teapot Dome scandals which broke open after Harding's

ment men. Their chief victim was President Harding." Called Small-Timer  
At best, Harding has been described by many historians as a well-meaning poker-playing small-time politician who won the Republican nomination in a "smoke-filled room" and captured the Presidency by telling a war-weary nation that he would lead America back to "normalcy."

Nor did the strange circumstances surrounding his death do anything to change the prevailing opinion.

He died while President a few days after suffering an attack of ptomaine poisoning later complicated by pneumonia. The ptomaine was blamed on crab meat eaten either in Vancouver, British Columbia, or on board the naval transport Henderson.

But none of the other members of his party suffered from the scandal that Harding, disillusioned by the scandals that were already breaking in his administration and aware that more were to follow, had taken his own life.
