**Small Car Insurance  
Premiums Reduced**

Menlo Park, Calif.—UPI—All-  
state insurance company has  
announced a 10 per cent dis-  
count on insurance premiums for  
compact and small cars.

J. Mason B. Branch, company  
president, announced Wednes-  
day that experience showed  
smaller cars cause less dam-  
age in an accident than stand-  
ard size cars. He said the  
special discount would be ef-  
fective Nov. 1 in California,  
Illinois, West Virginia, Mon-  
tana and other states where  
the program has been approv-  
ed by the state insurance de-  
partment.

The special discount cover-  
age will apply on bodily in-  
jury, property damage, col-  
lision and medical payments  
for private passenger autos of  
limited size, weight, horse-  
power and value.

**Effigy of USC  
President Hung**

Los Angeles—UPI—An effigy  
of Dr. Norman Topping, pres-  
ident of the University of  
Southern California, was re-  
ported to have been hung  
Wednesday night by about  
1,000 students.

Police said the students  
gathered on 28th st., along  
"fraternity row," and blocked  
traffic. Officers said the stu-  
dents apparently were up in  
arms over recent stringing  
rules imposed by the univer-  
sity on fraternity activities.

A sign on the effigy read,  
"There are no gods on the  
row."

One fraternity, Kappa Sig-  
ma, was banned from the  
campus after a pledge, Rich-  
ard Swanson, 21, choked to  
death on a piece of oil-smear-  
ed raw liver during an initia-  
tion ceremony Sept. 17. A cor-  
oner's jury ruled that Swan-  
son's death was accidental.
