Summit Meeting Without Delay Macmillan's Goal

Late November or Early December Seen

London (UPI)—Prime Minister Harold Macmillan, brimming with new energy after his election triumph, told his Cabinet today that his next goal is an East-West summit meeting without delay.

Government sources said he was shooting for one in late November or early December—the first, in fact, of the "continuous chain of summits" he wants.

Macmillan returned to London after a week end rest at his Sussex country home from the strain of electioneering and the battle at the polls which his Conservative party won handily.

Plans Outlined
He met with his Cabinet at No. 10 Downing st. for the first time since the results came in.

A summit meeting in the next few weeks.

A minor revamping of his government.

With last Thursday's election out of the way, government sources said Macmillan planned to concentrate much of his effort on an all-out drive for the summit.

They said he may fly to Washington soon to confer with President Eisenhower on the results of the President's meetings with Soviet Premier Nikita Khrushchev.

British press reports from Washington said French President Charles de Gaulle also might be invited to Washington for a pre-summit conference—perhaps while Macmillan is there. These dispatches said, however, that it is not certain that the domestic situation in France and the Algerian war would permit de Gaulle to go to Washington.

Diplomatic sources said Macmillan favors a short Big Four foreign ministers' conference to prepare for the summit and then an actual summit get-together in Geneva within the next two months.

Neuberger Cites Notes To Show Thanks Expressed for Hearing

Senator Refers To John Hayes' Week End Remark

Eugene Hearing on Dunes Bill Argued

Portland (UPI)—Sen. Richard L. Neuberger (D-Ore) cited a court reporter's notes today to show that an opponent of his Oregon Dunes National Park bill admitted at last week's hearings in Eugene that Neuberger treated him in a "very fair manner."

Neuberger was referring to John M. Hayes, chairman of the Western Lane Taxpayers Association, who said during the week end that the senator's subcommittee hearings at Reedsport and Eugene were "reminiscent of the Spanish Inquisition."

Hayes conceded in his week end statement that Neuberger was "rather fair" to him and his organization, but added that "I think it was to be expected, as we represent a considerable number of voters on the coast."

Hayes criticized Neuberger for his treatment of Dan Allen, chairman of the governor's natural resources committee, causing the senator to remark today, "doesn't Mr. Hayes think the governor represents any voters?"

"I treated Dan Allen the same way I treated Mr. Hayes," Neuberger said.

He quoted from stenotype notes taken at the hearings to show that Hayes rose at the end of the Eugene hearings and said:

"I wish to thank you and the committee for the very fair manner in which you treated the Western Lane Taxpayers Association and your willingness to allow us the full hour to make our presentation."

Neuberger said Hayes thanked him two other times during the hearing for allowing "uninterrupted time" to present his case.

"The people of Oregon can decide whether they ever want to rely upon the testimony of a man who rises voluntarily at an official U. S. Senate hearing and thanks the chairman for treating him and his associates in a very fair manner," he then talks darkly, after the hearings are concluded, about conduct "reminiscent of the Spanish Inquisition," the senator said.

Neuberger added that Hayes apparently "wants to have his cake and eat it too" in admitting he received fair treatment, but that other witnesses did not.

Hatfields Resting Comfortably After Auto Collision

Salem (UPI)—Gov. and Mrs. Mark Hatfield were reported resting comfortably at their home today, but still under the care of their personal physician as a precautionary measure after being shaken up when a car bumped into their car while it was waiting for a traffic light in Portland Sunday afternoon.

En Route To Salem
Gov. and Mrs. Hatfield were en route to Salem after seeing part of Vice President Richard M. Nixon's party to their plane at the Portland International Airport. Their car, driven by Cpl. William Newell of the state police, had stopped for a red light. The governor's official black Cadillac limousine was struck from the rear by another vehicle.

The force of the collision knocked the limousine about 12 feet and smashed in the rear end. The governor's car collided with but did not damage a third car stopped in front of it. Neither the driver

Nobody was hurt, but a number of people were probably startled when a rampaging rifle bullet finally stopped against a light switch in a neighbor's house Saturday afternoon, Medford police said.

Harry Eugene Whitlock, 1624 Lenora st., was running shells through a .32 caliber special lever-action deer rifle at his home after getting it back from a gunsmith. Apparently it accidentally fired, police said.

A shell went through Whitlock's bed, out through a wall of his house, shattered a neighbor's window across the street and hit a light switch inside the house. Although a number of children were playing nearby, miraculously, nobody was hurt.

Two-Story Building Damaged by Wind

A two story U.S. forest service warehouse-bunkhouse at the Lake of the Woods ranger station was damaged early Friday morning during a wind storm, forest service officials reported today.

Two trees, 20 and 30 inches in diameter, sheared off the entire end of the building, it was reported. The building, unoccupied at the time, contained fire tools and equipment on the first story with the dormitory space on the second floor.

Although no other damage was reported to government property in the immediate area, wind damage may be discovered later to homes near the lake.

Forest service engineers are currently at the scene appraising the warehouse damage so repairs may be made prior to snow fall, local officials said.

Polaris Missile Falls Short of Planned Goal

Washington (UPI)—A long-range Polaris test missile fired today from Cape Canaveral fell short of its planned 900-mile flight the Navy announced here.

The Navy said that the flight of the advanced design missile "was terminated early for reasons not yet known."

Walkout May Resume After Order Expires

Fact-Finders Seek Strike Solution

Washington (UPI)—The striking United Steelworkers' union said today its members would return to work under a Taft-Hartley injunction. But it hinted that the walkout would resume after any such court order expires.

David J. McDonald, union president, made the veiled threat of a renewed stoppage in a statement submitted at the opening of hearings by a presidential fact-finding board. The panel is attempting to settle the 90-day-old strike by voluntary agreement while paving the way at the same time for a strike-stopping injunction if its peace effort fails.

President Eisenhower opened the way for the government to obtain an 80-day no-strike injunction by creating the board of inquiry last Friday.

"The single issue in this strike is whether the companies will break the union," McDonald said. Industry officials were expected to testify later.

"There may be a truce enforced by law but there will be no permanent peace," he added, hinting at a renewal of the stoppage once a court-ordered cooling-off period ended.

He accused the industry of demanding "unconditional surrender" during negotiations for a new contract.

The steel companies will give their side of the case to the board Tuesday.

Meanwhile, Assistant Senate Democratic Leader Mike Mansfield said Eisenhower should "start knocking heads together" before Friday by calling the first string union and management teams to the White House and using every means at his command to get a negotiated settlement without imposing the Taft-Hartley Act.

John A. Perl, 85, pioneer funeral director in southern Oregon, died this morning in Portland. He had been in failing health for two years.

Mr. Perl, who made his home on Coleman Creek rd., was active in many civic and fraternal organizations and was a member of First Presbyterian church. He founded the Perl Funeral home here more than 50 years ago.

His wife, Jean, died in January, 1954.

Survivors include one son, Frank Perl, Medford; three grand children, William F. Perl Jr., San Francisco; Mrs. Robert Zundel, San Leandro, Calif.; and Jack Six, Medford; and five great grandchildren.

Funeral arrangements will be announced by Perl Funeral home.

Klamath, Calif., Man Dies as Jeep Upsets

McCleod, Calif. (UPI)—Jack Critie, 51, Klamath, Calif., was killed about 3 a.m. today when his Jeep fell from a frost covered bridge on Ponderosa rd. 28 miles east of McCleod and overturned on top of him.

Doctors today were more optimistic about the infant's recovery. They said it has now been more than five days since she was separated from her sister Denett in a five-hour operation and Jeanett has rallied several times from extremely critical condition.

Doctors said she appeared to follow a pattern each day, with her condition worsening each night and then improving the following morning.

Denett today continued her steady slow improvement. Denett, although still in an oxygen tent, has been taking three to four ounces of formula regularly, attendants said.

The girls' mother, Mrs. James Stubblefield, of Parma, Idaho, was allowed to hold Denett Sunday, the hospital spokesman said.

City Officials on League Program

Speaking Monday morning will be Paul Selby, chairman of the city planning commission, who will talk on the improvement requirements in subdivision regulations.

Tuesday discussion leaders and speakers from Medford include Fred E. Robinson, city councilman; Mayor John W. Snider, chairman of the League committee on city-highway relationships; O. R. McNeel, director of building safety, who will speak on an in-service training program; and Chief of Police Charles P. Champlin.

Robert L. Haworth, Medford park and recreation director, plans to attend the annual meeting of the Oregon Parks and Recreation association to be held at the same time in Portland.

Duties of the new state parks and recreation director will be explained and new officers elected for the year, Haworth said.

Elkins Conviction Will Be Reviewed

Washington (UPI)—The Supreme court agreed today to review the wiretapping conviction of James Butler Elkins, and his employe Raymond C. Clark, both of Portland, Ore.

The court will set dates for arguments in the case and hand down a written opinion later.

Physician Killed, Foe Wounded in Gun Scrape

Radford, Va. (UPI)—A physician was fatally shot and a prosperous oil dealer was seriously wounded Sunday night when they shot it out on a dark country road before the oil man's estranged wife and daughter.

Wounded in Abdomen
Dr. William Flanagan, 31, Christiansburg, Va., died at a Radford hospital from a .22 caliber pistol bullet that entered his mouth and lodged in his spine. His adversary, Christiansburg Councilman E. Garland Higgins, 35, was in fair condition today at a Christiansburg hospital with a .38 caliber bullet wound in the abdomen.

The duel followed an auto chase in which Higgins cut off a car carrying Flanagan and Higgins' estranged wife and 5-year-old daughter.

Commonwealth's Attorney Julius Goodman said a murder warrant would be issued against Higgins.

Goodman said the two swerved his car in front of the Flanagan auto.

The attractive woman and little girl sat helplessly as the two men leaped from their cars and opened fire.

Judge Sends Sharp Answer to Board's Criticism of Case

Circuit Judge Edward C. Kelly has written a letter sharply criticizing the state board of control for its actions with respect to the case of a 16-year-old Ashland youth at MacLaren School for Boys.

The board, considering a request from MacLaren's superintendent that the youth be returned to juvenile authorities here as "incorrigible," had questioned the courts here and in Clackamas county for committing the youth to MacLaren.

The board, according to the minutes of its Sept. 29 meeting, considered this "obviously a case which should never have been committed to MacLaren in the first place in view of the long history of delinquency."

Umpire Decision
"It is respectfully suggested," Judge Kelly replied in his letter mailed Friday, "that if the board is going to umpire decisions of the courts in these matters, the least that should be done in the interest of accuracy is to conduct a reliable investigation of the case upon the ground from direct witnesses, instead of resorting to hearsay and opinion compiled 250 miles away."

Judge Kelly pointed out that the conclusion of "the long history of delinquency" had been reached by the board on the basis of a "hearsay report from MacLaren" instead of investigation here in Jackson county.

The board, according to its minutes, was "reluctant" to return the boy to juvenile court here "unless there was some assurance that steps would be taken by the courts to bring him to trial."

Judge Kelly accused the board of seeking "to abridge this basic constitutional provision" of separate powers.

"For the board's information," he added, "the responsibility for prosecution of criminal offenses rests with the district attorney. It is the responsibility of the court to see that a person accused of crime receives a fair and impartial trial. This obviously cannot be done if the court is required to give 'assurance' that a person will be brought to trial for possible sentence."

Salem (UPI)—A disturbance at the new Oregon Correctional Institution six miles south of here was termed a "minor noise making demonstration" early today by Col. William Ryan, secretary of the State Board of Control. He said he had "no idea of the cause" of the trouble.
