Attorney Explains New Juvenile Code

The setting up of a juvenile code for Oregon and the passing of a post-conviction law are considered by District Attorney Thomas J. Reeder as the most important changes by the 1959 Legislature pertaining to the criminal code.

Speaking before members of the Medford Business and Professional Women's club Thursday at the Girls Community club, Mr. Reeder also commented on other changes made during the recent legislature session.

The speaker explained that the juvenile code, which will go into effect January 1, 1960, states that all juveniles under 18 years of age will be under the jurisdiction of the juvenile court.

For felonies, he said, the juvenile judge may then refer the youth to the district attorney's office for prosecution.

He added that he thought the code was long overdue.

In speaking on the post-conviction law, Mr. Reeder mentioned the numerous writs and other legal proceedings filed by persons convicted of crimes while serving time in the state penitentiary.

The district attorney explained how such proceedings tie up personnel and courts in hearings. The new law will eliminate the continual filing of writs, he said. Once such proceedings are filed by a prisoner a hearing will be held to consider all matters where in he claims he has been denied due process of the law.

The hearing provided for the post-conviction law shall be conclusive.

The speaker explained that the 1959 Legislature revised the penalties on many statutes thus establishing more uniformity, although he stressed that many of the statutes should be brought up to date.

He commented highly on the appointment of a legisla-

tive interim committee to recommend whatever changes appear to be needed in the criminal law.

The district attorney also mentioned the change in the laws governing shoplifting. A merchant may now detain a person for a reasonable time as a suspect without the merchant being liable for legal action for false arrest.

The simplification of statutes concerning the smoking of tobacco products in public places by minors under 18 years was also mentioned by the speaker. He said that many of the unworkable features of the law were removed.

In concluding, Mr. Reeder stressed that numerous changes were made in criminal laws by the legislature.

Following his talk a question and answer session was held. Asked about making of a "citizen's arrest," the district attorney explained that before making such an arrest the person should be sure that a crime has been committed. In the event a private person should make such an arrest he should be well aware of the limitations imposed upon him in doing so, he said.

Also speaking at the meeting was Mrs. William B. McCullough, woman's page editor for the Ashland Daily Tidings and member of the Ashland BPW club. Mrs. McCullough, who was the "Beep of the Week" for the Ashland group during the National Business and Professional Women's Week October 4-11, gave highlights of her recent four week trip through Canada and to the East coast.

While in Washington, D. C., Mrs. McCullough attended a cocktail party at the Russian embassy September 24 for Soviet Premier Nikita S. Khrushchev. She also visited the national BPW headquarters in that city.

New members welcomed into the club were Mrs. Betty Fichtner, Miss Carolyn Fichtner and Miss Rita Rose.

Mrs. F. R. Faulkner, club president, announced plans for the fall conference of the southern Oregon district to be held in Ashland, October 31 and November 1.

Speakers for the conference will be Miss Fern Trull, Grants Pass, national chairman of the international relations committee, Mrs. Lucille Norton, Eugene, second vice president of the state federation; and Mrs. Fedora Wonnacott, Newberg, Oriental scholarship chairman for the state federation. 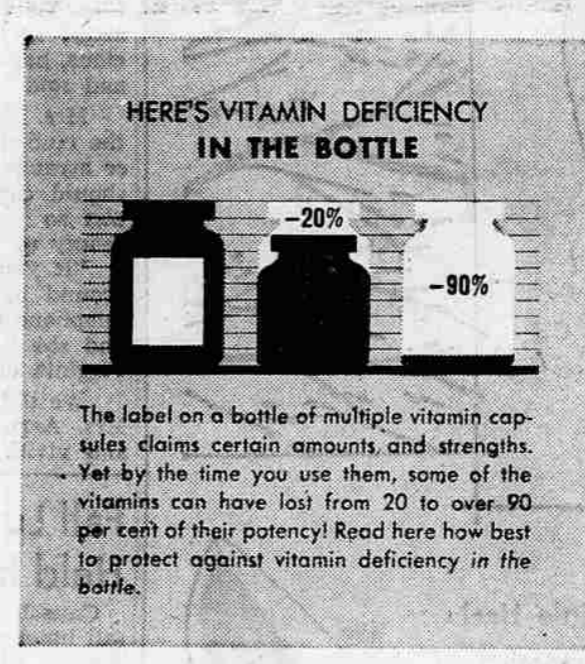

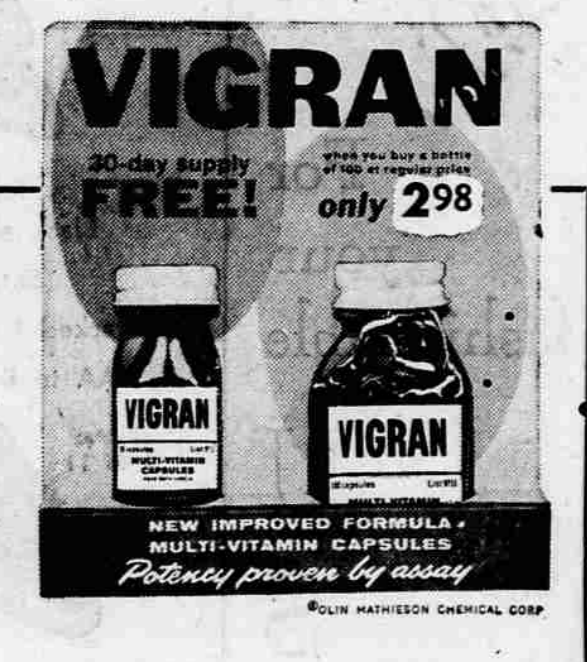
