The automobile was demolished. The accident occurred about 1:20 a.m.

New Aerial Survey System Given Tests

Los Angeles (Science Service)—A new electromagnetic surveying system that can penetrate the earth five to six times deeper than conventional systems has been successfully tested.

Fairchild Aerial Surveys, Inc., here, said the new AFMAG system is designed to locate copper and lead ores. It uses natural electromagnetic fields of the earth as a source of energy.

This obviates a transmitter and is said to enable AFMAG surveys to be made from conventional aircraft at speeds and elevations previously impractical.
