The Family Council

Editor's Note: The Family Council consists of a Judge, a psychiatrist, three clergymen, a newspaper editor, a women's editor and two writers. Each article is a summary of an actual case history. The Council reports on problems that have been dealt with by responsible agencies and counselors.

Bernice R. - I'm afraid I still love my husband.

Bill D. - He'll never make a decent husband.

Bernice R. - Two years ago I was going steady with a young man I had known from childhood. We were planning to marry.

Then I met an older man who had been divorced twice. He swept me off my feet and we married within a matter of weeks. Only a few months after our marriage he started going out with other women and has been doing so since.

I have been driven almost crazy and I want out. My old boy friend says he still wants to marry me - in spite of the fact that I now have a 6-month old baby. But I'm afraid I still love my husband and I am still unsure about Bill.

Bill D. - Some girls don't know what is good for them. They shouldn't be given a chance to have a choice about their marriages. I told Bernice this guy was no good. I was willing to eat my hat if he turned out a decent husband. Now there's plenty of proof I knew what I was talking about.

I am willing to save Bernice from this situation whether she loves me or not. I hate to see this other guy get away with murder. I am trying to make Bernice understand she won't find another sucker like me, willing to take her on with a baby. I just feel so sorry for her that I'd do it.

The Council - Aside from the fact that Bernice is a married woman and is, at present, in no position to consider marriage proposals, we would warn her against suitors in Sir Galahad's clothing.

When an emotionally mature man wishes to marry, he thinks in terms of finding happiness for himself and giving it to his partner. He does not see himself as a "sucker" stooping to help some pathetic waif. Of course, the damsel in distress always has a certain appeal to the male ego, but the distress should not cause a man to look upon the lady with contempt.

It is contempt that Bill shows for Bernice when he says that he is willing to

marry her because he is "so sorry for her." No self-respecting woman would consider such a proposal. It is a preliminary in Bill's mind to a marriage in which he would every day throw up to Bernice her failings, with the object of building himself up to heroic proportions at her expense. Bill is seriously lacking real self-esteem and until he finds this, he is a poor risk as a marriage partner.

Bernice's real problems are elsewhere. There is a question of whether she can get her husband to accept married life or not. If he can't, she may well find life with him intolerable and may have to find other living arrangements for herself. In solving these serious problems, she may find the need of intensive help from an outside agency - a clergyman, doctor or family counseling service.

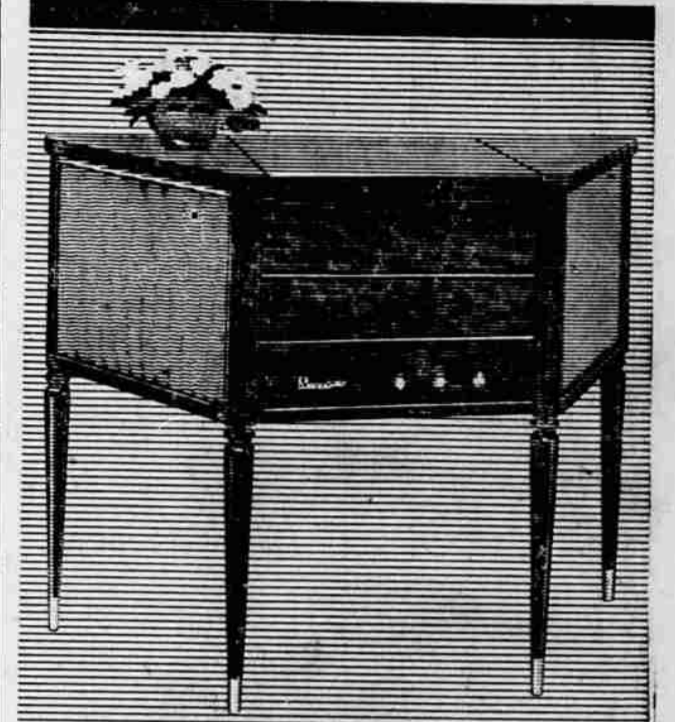

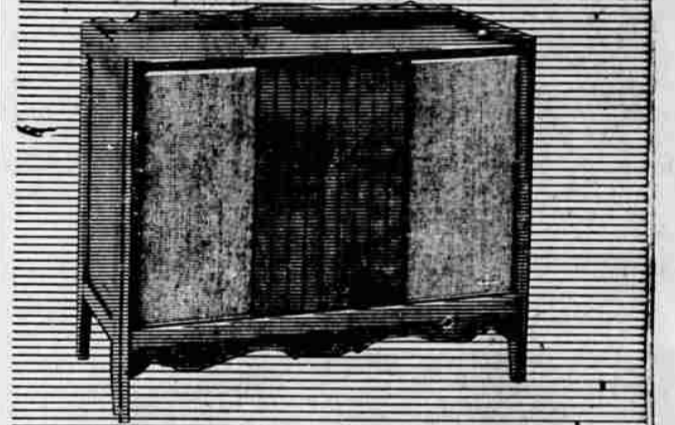

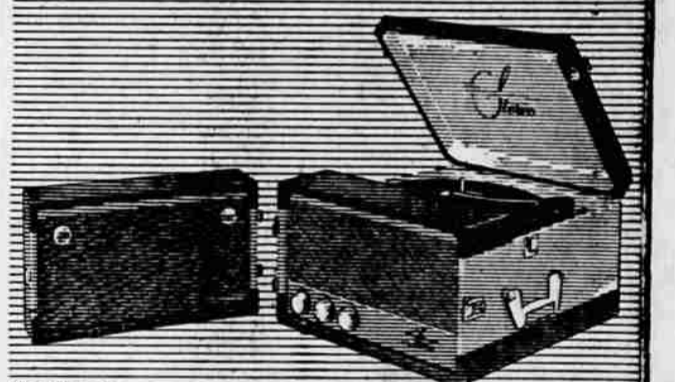
