Junior Achievement Program Is Reviewed at Roundtable

Junior Achievement companies are run entirely by high school students from beginning to end. Approximately 85 per cent of Junior Achievement businesses make a profit.

Youths form a business, sell stock, make a product, sell the product, liquidate the business, and declare dividends, if any, all in the course of an eight month period.

These features of Junior Achievement were pointed out at the Jackson County Chamber of Commerce roundtable luncheon Monday by Richard A. F. Ballou, the western regional representative for Junior Achievement, Inc., whose office is in San Francisco. He was in Medford helping civic leaders to determine the feasibility of having such a program here.

It is a program promoted by U. S. businesses to give youth a pre-business education, he said, by helping them to form small firms through which they will gain knowledge of how the free enterprise system works.

The program was started in 1919 in Springfield, Mass., by several businessmen who felt that suburban youth should have a business training program comparable to agricultural programs that were in existence for rural youths, such as the 4-H and Future Farmers of America, he said.

In 1958 there were 4,000 JA businesses in the U. S. and Canada with a total approximate budget of \$3 million, Ballou said. Nearly every major city in the country now has a JA program for high school students.

Eugene and Portland have JA programs, and Ballou said it is possible for Medford to have one if the community wants it.

The program applies to high school students, both boys and girls, between the ages of 15 and 19. On one day at the beginning of each school year, Junior Achievement directors go into a high school and tell the students about the program. Ballou said that in almost every community where there is a JA program, more than twice as many students sign up for it as can possibly be used.

Selection of students for the program are not made on the basis of achievement, but on the basis of ability and potential, Ballou said.

The students selected for the program are divided into groups of 15 to 20 persons. Each group will meet in a building or office set aside for that purpose, and at the first meeting will choose a product to make, a name for their company, and apply to Junior Achievement National for a charter.

Each JA business will have a sponsor in the community, preferably a manufacturing company. The sponsor will provide three advisors from his employ who will be trained by Junior Achievement National in how to help the JA company.

They are advisors only, and all work is done by the members of the JA company. Each advisor will help the company in one of three areas—management, sales, and promotion.

After the charter has been received, Ballou said, the company then raises its own capital by selling stock. The company can sell no more than \$150 worth of stock at 50 cents a share. No one person may purchase more than five shares apiece. Each member of the company must also buy at least one share.

When the needed capital is raised, the company elects officers, which usually include a president, vice president, secretary-treasurer, production manager, sales manager, and safety manager. Elections are held twice during the life of the company, so each member will have the opportunity of being an officer, he added.

The company then buys raw materials for its product and goes into production. Ballou noted that each company pays its own taxes, and pays wages to its members.

The company enters into valid contracts for its raw materials and contracts for its markets too, if possible, he said. The company will also lease the building in which it does business, and the machinery it uses in its operation.

In other words, Ballou said, the JA company will conduct all operations and encounter the same problems as the normal business does only on a smaller scale.

The business meets one night a week for two hours, and all production is done at these weekly meetings. Selling is done by the individuals on their own time, he said.

First Product

The first product of a JA company is usually one selected by its sponsor, but after that the business is free to switch to another item if it chooses, Ballou said, which is often the case, for it may lose money on its first product or see opportunity for greater profits by producing another.

The business may also borrow, he said, but from regular JA banks which are set up for that purpose. However, they can only borrow up to 25 per cent of their capital, Ballou added.

Products of the JA business must be competitive with products on the market, Ballou said. These businesses are not allowed to undersell any comparable product that is already on the market. He stressed this point in making it clear that the business atmosphere encountered by a

Snoqualmie Pass To Reopen Soon

Seattle - (UPI) - Paul J. McKay, district highways engineer, said today he hoped the flood-closed cross-state Snoqualmie Pass highway would be reopened this week.

The announcement came after crews were successful in diverting the south fork of the Snoqualmie river into a new channel. If weather permits, engineers hope to have a detour around a washout area, nine miles east of North Bend, completed by Thursday or Friday.

The diversion step was considered the major hurdle in enabling the opening of the road. The new channel runs for about 1,400 feet. In order to get the job done, State Highway Department crews used every available piece of equipment possible to speed operations.

Under Selection 'Likely Any Day'

Salem - (UPI) - The Oregon Voter in its Dec. 5 issue said Oregon State Treasurer Sig Under is "likely any day" to accept a federal appointment from President Eisenhower.

Under is winding up his second term as treasurer and is ineligible for a third term. He has never confirmed nor denied the speculation.

One of the posts unofficial sources consider Under might get is governor of Guam. Oregon Voter quoted Under as saying that appointment would be a "surprise" as "Guam has not been mentioned to me."

If Under leaves office, Gov. Mark Hatfield would appoint a successor.

Hillcrest Girls Have Short Freedom

Salem - (UPI) - Officials of Hillcrest School for Girls said two girls ran away Monday but were back in custody about four hours later.

Mrs. Chloris Brownell, assistant superintendent, identified the runaways as Jeannie Conlin, 18, of Eugene and a Salem girl, Sharon Lou Carey, 16. State police picked them up.

Supreme Court Rejects Appeal For China Travel

Washington - (UPI) - The Supreme Court has refused to interfere with the State Department's practice of not allowing some American citizens, including a congressman, to travel in Communist China.

In a brief order without a written opinion, the court turned down appeals from lower court rulings upholding the department's right to deny passports to Americans who want to travel behind the Bamboo Curtain.

The appeals were filed by William Worthy Jr., a reporter for the Baltimore Afro-American; Waldo Frank, a writer and lecturer, and Rep. Charles O. Porter (D-Ore.).

Meeting for the first time in two weeks, the court also agreed to speed up its consideration of lower court rulings barring the controversial civil rights commission from Louisiana and, in effect, from the entire South. The court scheduled oral arguments on the case for Jan. 18.

Reject TV Appeal

In another major action, the court also: -Rejected an appeal by former Federal Communications Commissioner Richard A. Mack and his attorney, Thurman A. Whiteside, from the ruling of Federal Judge Burnita S. Matthews denying them a directed verdict of acquittal on conspiracy charges. The two were accused of conspiring to rig the FCC's award of Miami television channel 10.

-Refused to review the contempt of Congress conviction of Horace Chandler Davis, a former University of Michigan instructor who refused to answer questions about Communism put to him by a subcommittee of the House Committee on Un-American Activities. He was sentenced to six months in jail and a \$250 fine.

Passports Were Refused

In the passport controversy, Worthy, a Negro, violated State Department regulations by going to Red China in 1956. The Department then refused to issue him another passport unless he promised not to try to go to China again.

Frank wanted to go to the University of Peking to lecture on American literature, write a book about China, and act as a correspondent for some Spanish and Portuguese newspapers.

Porter said he wished to get some first-hand knowledge of Red China, to help him as a legislator.

All sued to get passports when the State Department turned down their applications. They lost in lower courts. Porter's case hasn't yet been ruled on by the U. S. Court of Appeals here. But the congressman asked the Supreme Court to hear it anyway, along with the Frank and Worthy appeals.

Women Elected To Posts in Waterloo

Waterloo, Ore. - (UPI) - The women are on the move in Waterloo.

Voters in this Linn county community Monday elected two women to the city council for the first time in Waterloo history. Although Waterloo has a population of 170, only two dozen voters turned up at the polls to elect Mrs. Betty Vaughn and Mrs. Barbara Atchley.
