Editor's Note: The Family Council consists of a Judge, a psychiatrist, three clergymen, a newspaper editor, a woman editor and a writer. Each article is a summary of an actual case history. The Council reports on problems that have been dealt with by responsible agencies and counselors.

Mrs. B. S.-Her husband is playing with fire.
Elaine R. - He refuses to change his job.

Mrs. B. S.-I am a woman who was deserted by my husband ten years ago after a marriage of 15 years. He just met a younger, prettier woman in the place where he worked and went off with her, leaving me with three children.

By the time the law caught up with him I didn't want him back. I finally made a settlement with him and agreed to a divorce. I guess it was foolish because now I hear he is very unhappy with his second wife.

Anyway, I don't want my daughter to go through the same thing. She has a handsome husband who is a door-to-door salesman. All day he deals with women. I think this is playing with fire. My daughter should insist that he give up this work.

Elaine R.-It's all very well to talk about insisting, but I just can't with my husband. He is extremely stubborn. He gets his own way in everything. I can't do a thing with him.

When I speak to him about this and question him about the women he meets he just laughs at me. He says he loves me and isn't that kind of guy. But we have been married only four years. I don't know how he'll feel ten years from now with so much temptation in his way.

My husband says he's making a very good living with what he's doing and I should be satisfied with that and stop pestering him. I told him I'd be glad to do with less and not have to worry every time he walks out of my house. He is too much like my father in many ways.

The Council-It is natural for Elaine to worry about such matters since she suffered a serious wound in the past because of a man's desertion. Her father's desertion alone would be enough to make her uneasy, but her mother's dire warnings make things much worse.

Unfortunately, how ever, probing and questioning a man on such matters tends to create difficulties rather than evade them. If Elaine's husband is a devoted husband and father, he might have been unconscious of the temptations lurking for him in every door. She has now called this fact to his attention and she has seriously annoyed him with her suspicions.

There are temptations everywhere for both men and women who are looking for just that. Elaine has no guarantee that one very aggressive woman won't make a play for her husband at another job where there are fewer women in less intimate backgrounds.

In the long run, Elaine's only security lies in her husband's standards and character and in the quality of their marriage relationship. Even men of high standards can be driven to ugly actions by wives who make life miserable.

Woman Injured in One-Car Accident

A one-car traffic accident was reported to state police Monday at 8:50 a.m. on Highway 99 about two miles south of Medford.

Police said a car operated by Ada Sarah George, Seattle, Wash., went out of control on icy pavement and slid off the road, landing on its top.

Mrs. W. R. Mackintosh, a passenger in the vehicle, complained of a sore back, but police did not know if she went to a hospital. There were no other injuries, they said.

The George car was traveling slow at the time it went out of control, police said, but the highway at that point was a sheet of ice. Police said they helped about six other cars which slid into ditches in the area.
