Committee to Select President

Eugene-Chancellor John R. Richards announced today the appointment of nine members of the University of Oregon faculty to serve as a presidential search committee to assist the state board of higher education in its selection of a new president for the university. President O. Meredith Wilson has resigned to become president of the University of Minnesota on July 1.

Chairman of the committee will be C. Ward Macy, head of the economics department. Ivan M. Niven, professor of mathematics, will be vice chairman and Wesley C. Balaine, professor of business administration, will be secretary. Other members of the committee are William C. Jones, dean of administration; Robert D. Clark, dean of the college of liberal arts; Frederick A. Cuthbert, professor of landscape architecture; Edmund Cyker, professor of music; Ernest G. Moll, professor of English, and Earl Pomerooy, head of the history department.

Three members of the state board of higher education will also serve on the committee in an advisory capacity. They include Charles R. Holloway Jr., Henry F. Cabell and Douglas McKean. Milton W. Rice, president of the University of Oregon, will also serve on the committee.

Richards stated that the committee will meet in the near future to begin its nationwide search for a successor to President Wilson. He indicated that, because of the importance of the position and the magnitude of work involved in screening candidates, a decision by the board of higher education may not be made for at least six months.

Russian Nuclear Scientist Dies

Moscow—Soviet Physicist Dr. Igor V. Kurchatov, 58, who played a leading role in the development of the Soviet Union's nuclear program, died Sunday of coronary thrombosis.

The Soviet news agency Tass said Kurchatov would be buried today in Red Square near the wall of the Kremlin—an honor accorded only the most outstanding citizens of the U.S.S.R.

The physicist was regarded by many western scientists as the most prominent figure in the development of atomic energy in the Soviet Union.
