Police, a rescue squad and a doctor answered the emergency call. The doctor drove the child home to complete the examination and later reported to police there was nothing wrong with the child.

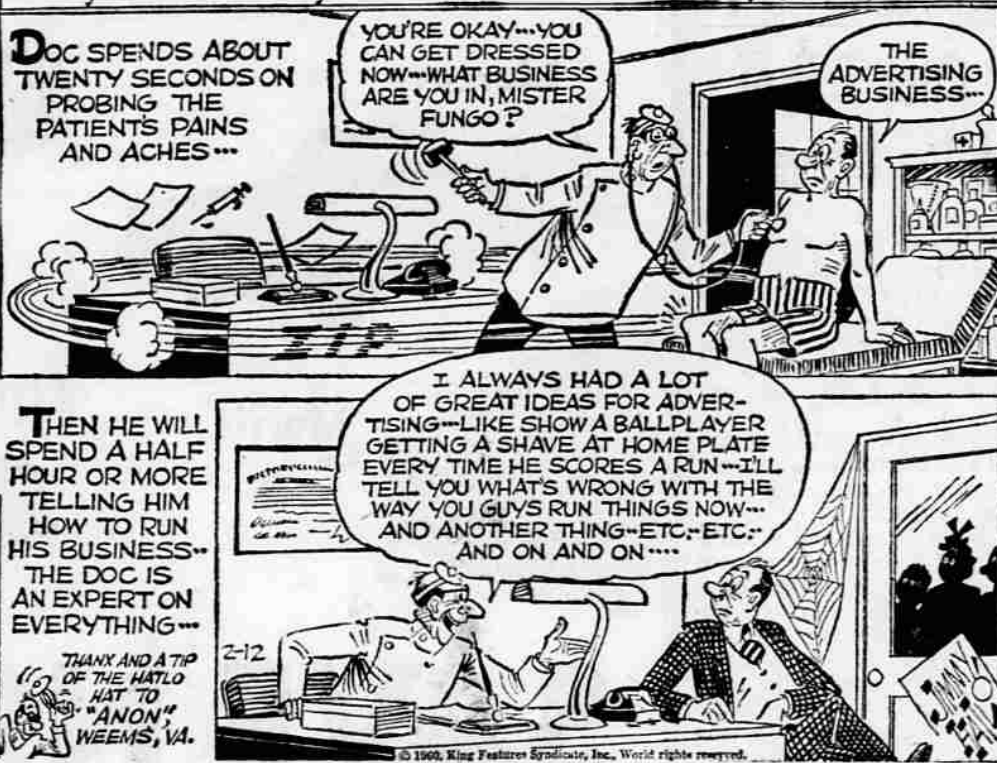
"He was tired and fell asleep," the doctor said.
