Special Election Possible

Wide-Open Race Seen Upon Death Of Russell Mack

Olympia, Wash.—UPI—A wide-open race for Third District congressman developed today in the wake of the sudden death of Russell W. Mack.

Mack, 68, a Republican, died Monday on the House floor.

At least eight persons were mentioned as possible candidates in a heretofore listless race that had attracted only one active challenger.

Democrats sensed their best opportunity to win the Third District seat since the popular Mack began his reign in 1947.

Republicans, caught without an active candidate, were sent scurrying for prospects in the event Democratic Gov. Albert D. Rosellini decides to call a special election to fill the unexpired term ending Jan. 3.

Rep. Julia Butler Hansen (D-Cathlamet), one of the most powerful members of the State Legislature, said she was considering entering the race.

John W. Riley, deputy state attorney general, is an unannounced but active seeker of the Democratic nomination.

Mayor May File
State Sen. Harry Elway, Hoquiam mayor, had been expected to file against Mack not as a serious candidate but to get "experience" for 1962. Mack's death made Elway an almost certain Republican candidate.

Also mentioned were two other Republican state senators, Dale Norquist of Centralia and Henry L. Schumacher, Vancouver.

A special election would be a real incentive to legislators, who still would be able to run for reelection in the congressional race.

Mrs. Hansen said she felt that Governor Rosellini should call a special election.

Bird's Beauty Marred By A Spoon

Someone with a flare for the aesthetic, or a true lover of flowers when their colors are delicate, must have observed carefully and finally came up with the name "flying orchid" to apply to a bird with a peculiar arrangement on the end of its bill.

For this instance is not a flower, but a bird—the roseate spoonbill. And the name fits, for the beautiful shadings of color on this bird really do resemble the exotic orchid.

Hardly any other bird in the entire world is more delicately tinted with rainbow and sunset hues than this long-legged wading bird. Nature endowed it with beauty, but its bill is grotesquely shaped. It resembles the wooden spoon so often seen in salad bowls, or the implement grandmother used in stirring apple butter.

There are a goodly number of spoonbills still living in some parts of the Florida Everglades. Regardless of how many of these beautiful but odd birds one sees, one never quite gets used to that funny looking bill.

No more ridiculous apparatus could be dreamed up than this ludicrous "spoon" that this bird is stuck with. He has to make the best of it; otherwise the spoonbills would surely starve to death. Nature compensated a little, or at least relented for a fleeting moment, by equipping this "spoon" with a system of delicate nerves whereby the bird can sort out food from mucky

waters without looking to see what has been picked from the bottom.

The birds take advantage of these sensitive feelers, for they swish the bill violently from side to side in the roiled water, about the same as a housewife would whip up cake batter with a perforated spoon. But if Nature pulled a fast one in bill equipment, she went to the other extreme in furnishing the bird with beautiful plumage. The colors show vividly, whether the bird is at rest or in flight.

"Flying Circus"
During hours of relaxation, usually just before sunset, flocks of spoonbills take off on a joyous "flying circus," ascending so high into the sky that from the ground they resemble dust particles in a ray of sunlight. Here they soar in great circles until the world below is nearly dark; then they come spiraling back to earth again.

Like many of the wading birds, the spoonbills nest in large colonies. The young are snow-white until they reach adulthood, a period of about three years. Then the rosy pink color begins to show and slowly spreads over the entire body like the red blush of a sunset.

Under rigid protection, the number of spoonbills seems to be increasing, and people intelligent enough to appreciate and understand that "a thing of beauty is a joy forever" are hopeful that the roseate spoonbill can be saved from total extinction.

Crosses Burned In Defiance of Demonstrations

Ku Klux Klan in Alabama and South Carolina burned scores of crosses over the week end in acts of defiance against Negro demonstrations protesting segregation in the South.

Dozens of flaming crosses were seen along highways in the Anniston, Ala., area Saturday night, and a fire bomb was thrown into the yard of a Negro home.

Witnesses reported seeing a white man throw the homemade bomb into the yard, but no damage resulted because the bomb failed to ignite.

Klanmen Hold Rally
Police said they received at least 100 complaints about the cross burnings in Alabama. Twelve men were picked up by police in connection with the incidents. Five were charged with obstructing a highway and later released, along with the others.

The cross-burning coincided with a huge Ku Klux Klan meeting in Monroeville, Ala. Hundreds of klansmen, many of them robed and hooded, held a rally at the regional Coliseum. Then they formed a motorcade to a home where a 20-foot cross was burned and new members were initiated.

Sitdowns Continue
Approximately 50 crosses were burned in a six-county area of South Carolina Saturday night, with as many as 40 reported burning at one time.

The cross-burning capped a full day of sitdown protests at Hampton, Newport News and Richmond in Virginia and the picketing of stores by Negroes in Savannah and Atlanta.

Chessman's Lawyer Files New Action; Attorneys Squabble

Los Angeles—UPI—Attorney George T. Davis filed a new court action Monday in an attempt to free Caryl Chessman from his May 2 death sentence and immediately found himself embroiled in a squabble with two other of the convict-author's lawyers.

A. L. Wirin of Los Angeles and Rosale Asher of Sacramento, Calif., blasted Davis for filing the petition in San Rafael, Calif., without first consulting them.

Wirin and Davis made up shortly after Davis flew into Los Angeles to hold a press conference about the latest maneuver to allow Chessman to escape the death sentence he has faced for 12 years.

Asher May Quit
But Miss Asher, who has represented Chessman since his San Quentin imprisonment in 1948, threatened to break off her association with Davis and Chessman.

"I can no longer work under these handicaps by Davis," Miss Asher said from Sacramento in a telephone interview with Los Angeles newsman Lew Irwin. "There is a 75 per cent probability that I will no longer work as Chessman's counsel."

Miss Asher complained that she had not been consulted about Monday's action by Davis nor had he informed her of the adding of three attorneys to his defense team. They were Barbara Warner, Los Angeles; Paul Posner, Los Angeles; and G. H. Van Harvey, an associate of Davis.

Davis Says No Trouble
Davis said after a brief conference with Wirin that their squabble was a "tempest in a teapot," just a misunderstanding. "The two attorneys agreed for the 'sake of our client' to mend their differences."

Hearing Scheduled
Davis, who has been associated with the Chessman case for about the past seven years, said the petition will be argued Wednesday in San Rafael before Superior Judge Jordan Martinelli. The judge then will either dismiss the petition or order a full-fledged hearing with Chessman present.

The petition raises for the first time the argument that Chessman was sentenced to death 12 years ago for a crime which actually carries a maximum sentence of life imprisonment, Davis said. The petition argues that two counts on which Chessman was sentenced

The cash and securities were found lying carelessly on a bed, stuffed in a mattress and shopping bags and scattered about the house.

It was discovered by off-duty policemen hired by Ray Duba, attorney for the sisters, to clean up the place during the women's absence.

Duba said the sisters are heirs to a small fortune through connections with the family of John F. Ugazzi, a rich San Francisco banker during the last century.

Duba, praising the honesty of his clean-up men said they deserved rewards.

But that would not be possible, he said, because the money is part of an estate put under a conservatorship by a Superior court.
