**African Police Seize Leaders**

Johannesburg, South Africa—(UPI)—Police seized at least 100 opposition political leaders, including some whites, today in raids aimed at cracking resistance to the South African government's segregation policies.

Zulu Chief Albert Lutuli, president of the South African branch of the African National Congress (ANC) was among those taken into custody in the raids here and in Pretoria.

The raids were the biggest crackdown on political opposition leaders since the so-called "treason" arrests of 156 persons in December, 1956. Arrested with Lutuli was John Brink, chairman of the Pretoria, branch of the Liberal Party, which has representatives in Parliament and which hitherto had been immune from such police crackdowns.

A white minister, the Rev. Mark Nye, was arrested as he went to the police station to arrange an attorney for Lutuli, who was supposed to be ment to his farm in Natal serving five year's banishment.

**Pair Convicted Of 4 Slayings**

Garden City, Kan.—(UPI)—An all-male jury found ex-convicts Richard Eugene Hickock and Perry Edward Smith guilty Tuesday of murdering four members of a prominent farm family and ordered them hanged by the neck until dead.

Smith, 31, and Hickock, 28, were convicted for the shotgun deaths of Herbert Clutter, 48, a prominent wheat grower and one-time Eisenhower appointee to the Federal Farm Credit Board, his wife, Bonnie, 45, and two of their three children, Kenyon, 15, and Nancy, 16.

The court appointed attorneys for the two killers said they would file a routine motion for a new trial. Such motions usually are denied. Both convicts admitted they killed the Clutters to "wipe out witnesses" after they broke into the Clutter farm home in Holcomb, Kan., last Nov. 15 to commit robbery. Their loot amounted to \$50 in cash, a portable radio and a pair of binoculars.

**Reward Offered in Oklahoma Bombings**

Oklahoma City—(UPI)—The Oklahoma Publishing Co. offered \$10,000 reward today for information leading to arrest and conviction of persons who bombed property of three of its employees last Saturday night.

Explosions occurred at the homes of three Oklahoma Publishing Co. employees who had been granted leaves of absence earlier to work briefly for struck newspaper at Portland, Ore.

**Oswego School Building Guffed**

Lake Grove Ore.—(UPI)—Fire this morning gutted the two-story frame administration building of the Lake Oswego high school.

The flames, of undetermined origin, were under control about 10 minutes after the alarm was turned in at 5:39 a.m., firemen said.

The fire roared through the five-room house that had been converted into an office building, and the major loss appeared to be in school records, fireman Richard Merritt said.

No damage estimate was available.

Merritt said that a recent bond issue approved by the residents provides for a new administration building along with other school additions. Other school buildings were not threatened by the fire.

**Ill Wind Blows No Good for Auto**

Mahwah, N.J.—(UPI)—It was an ill wind that blew no good as far as officials of Ford Motor Co.'s huge Mahwah plant were concerned.

The plant's one-millionth car, filled with 150 balloons, was being turned over to Mr. and Mrs. Donald B. Earle Tuesday. Five other balloons were attached to a set of keys which were in the trunk of the white convertible.

The 150 balloons, each bearing a postcard promising the finder a miniature replica of the milestone Ford, were released.

But an unexpected gust whisked away the five balloons attached to the Earles' keys.

They were last seen flying west.

**Cuban Requests Argentine Asylum**

Havana—(UPI)—Television commentator Luis Conte Aguerb, vowing his unalterable opposition to "Communist intrusion" in Cuba, sought asylum in the Argentine Embassy Tuesday night.

Conte, who has been in hiding since a Communist mob barred him from the TV studios Friday, sent a statement to newspapers and wire service bureaus here before fleeing to the embassy.

He said he felt pity rather than anger for the officials who had assailed his anti-Communist stand—especially Premier Fidel Castro's brother Raul, who "tried to whip up the lowest passions against me."

"I tried to help them, and they stabbed me in the back," Conte's statement said. "But there is a God in heaven, and history has eyes."

**California Man Arrested in City**

Medford police arrested a self-employed truck driver yesterday on a charge of larceny of an auto, following his apprehension in a car reported stolen from a lot at Skinner-Buick-Cadillac, 143 South Riverside ave.

Daniel Louis Minerva, 31, of Brooklyn, N.Y., was stopped in the car by a city police officer about 2:15 a.m., at the intersection of Ninth st. and Central ave., about 15 minutes after the car was reported stolen.

He admitted he took the car from the lot, according to police, and said he did it because he wanted to find some friends of his. They said he was cooperative following his arrest.

Minerva told police he had driven a truck to Medford from San Jose, Calif., a week ago and has been waiting here for further instructions.

He was lodged in the county jail.

**Judge To Hear Chessman Plea**

San Rafael, Calif.—(UPI)—Superior Judge Jordan Martinelli will hear arguments today at 2 p.m. in a new effort to save Caryl Chessman from the gas chamber.

The hearing follows an announcement Tuesday night that preliminary steps have been completed for an attempt to save Chessman by taking his case to the people.

According to Robert Bradford, a Monterey, Calif., writer, Secretary of State Frank Jordan has assigned a title for a petition to put on the November ballot an initiative measure to abolish capital punishment.

But it would be necessary that the petition obtain 420,000 signatures by June 18. Professional petition passers doubted that enough money and volunteers could be found to get signatures of all those voters.

Before Judge Martinelli, Chessman's attorney's will only argue that their current demand for a writ of habeas corpus deserves a full-scale hearing.

Chessman is scheduled to die May 2, and such a full-scale hearing might result in a stay of his ninth execution date.

**Corinne Calvert Awarded Divorce**

Santa Monica, Calif.—(UPI)—French-born actress Corinne Calvert was awarded a divorce Tuesday from actor Jeff Stone on her testimony that Stone's conduct was ruining her health.

"Everybody in town knew he was leaving me before I did," said the shapely actress. She said she screamed at her. "It made me so nervous I had to go on what you say... tranquilizers."

Miss Calvert, previously wed to actor John Bromfield, was awarded \$150 monthly support for her son, Robin Jr., 4, and 10 per cent of Stone's earnings over \$20,000 a year. The couple was married in 1955.

**Hearing Scheduled On Handicapped**

Washington—(UPI)—A House education subcommittee said today it has invited more than 600 persons from nine northwestern states to attend hearings at Portland, Ore., April 11 and 12 on rehabilitation and education of handicapped persons.

About 60 witnesses are expected to testify on the region's most urgent needs in the field of special education and rehabilitation. States included are Oregon, Washington, Alaska, Idaho, Montana, Utah, Colorado, Wyoming and New Mexico.

Similar hearings are scheduled for April 13 and 14 at Los Angeles.

**Two-Day Strike at Vandenberg Ended**

Vandenberg AFB, Calif.—(UPI)—A two-day strike by 3,000 civilian workers at this operational base ended Tuesday night, allowing work to resume today on Atlas and Titan launching pads.

Philco Corp., one of the private contractors employed by the Air Force here, agreed to withdraw 24 to 30 workers the International Brotherhood of Electrical Workers said were being paid below the prevailing wage scale.

Philco said talks with the union had become deadlocked and the disputed workers were being withdrawn so vital work on the intercontinental ballistic missile pads could be continued.

Further talks between the two parties were scheduled to iron out the dispute on whether certain worker classifications are subject to a rule governing wage scales.

**Washington Picks Site for Prison**

Olympia, Wash.—(UPI)—A 500-acre tract four miles northwest of Shelton was selected by the state Tuesday as the site of a proposed \$8,500,000 medium-security prison.

The site, to be donated by the City of Shelton, was chosen by Garrett Heyns, director of institutions, from a list of 29 bidders.

The 1959 State Legislature authorized the prison and directed Heyns to select a site and develop plans for construction. A start on the project is contingent upon the willingness of the 1961 Legislature to provide funds.

The proposed prison would employ 150 and 175 workers and have an annual payroll of about \$1 million, officials estimated.
