

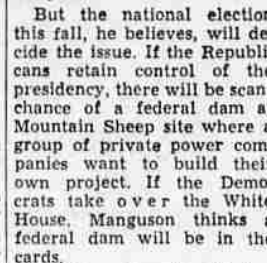
Lent Presents Contrast With Prevalent Way of Human Life

Magnuson Favors Snake River Dam Development

Washington—(Special)—Sen. Warren G. Magnuson (D-Wash.) favors federal government construction of high Mountain Sheep dam as the answer to the new riddle of conflicting power development on the Snake river below Hells Canyon.



But the national election this fall, he believes, will decide the issue. If the Republicans retain control of the presidency, there will be scant chance of a federal dam at Mountain Sheep site where a group of private power companies want to build their own project. If the Democrats take over the White House, Magnuson thinks a federal dam will be in the cards.

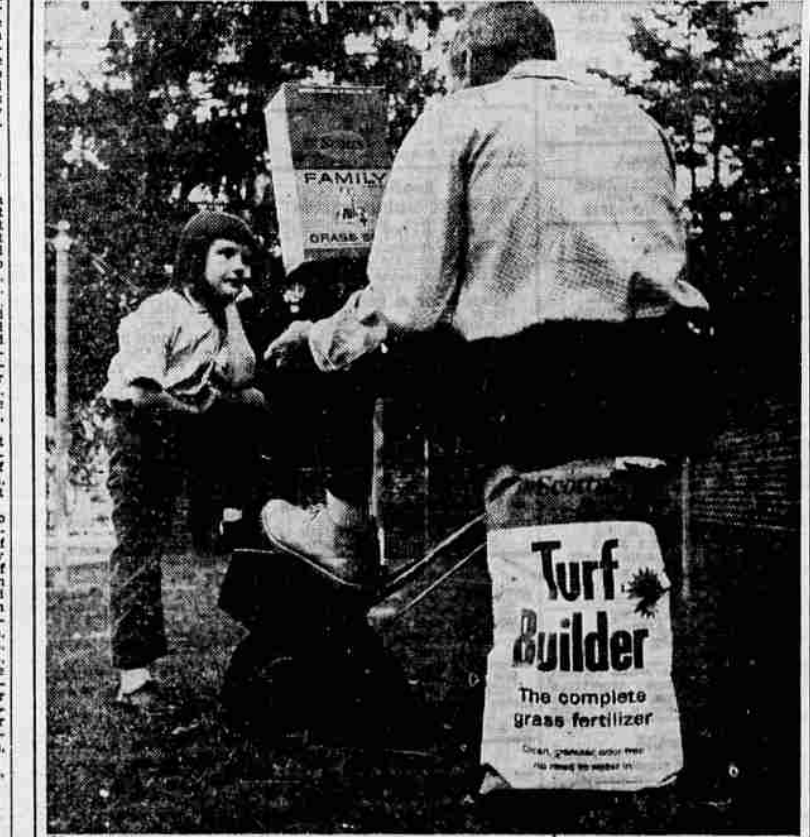
