

Better Qualified Teachers Lacking In Small Districts

By DOUGLAS GRIPP Salem - (UP) - Bigger school districts in Oregon tend to gobble up better-qualified teachers and this is a problem for small school districts.

Not only that, but it seems to be on the rise. So says a research paper delivered to the Legislative Interim Committee on Education, prepared by the University of Oregon's Bureau of Educational Research, the second in a series.

The report, titled "Educational Status of Oregon Teachers," states that larger districts recruit teachers with a greater amount of preparation, those with baccalaureate, master's and doctorate degrees.

The report suggests that "very careful attention" is needed in Oregon to upgrade the preparation of teachers in small districts and remote sections.

The paper, prepared under the direction of Keith Goldhammer, shows that in the 10 years from 1949 to 1959 big gains were made in the extent to which Oregon teachers were qualified for their jobs.

It also was learned that 81.8 percent of the state's teachers in the 1958-59 school year taught in western Oregon.

Eighteen counties in the eastern part of Oregon had only 3,060 of the state's 16,818 teachers, reflecting the population makeup.

In order to compare the educational level of teachers in different parts of Oregon, the researchers divided the state into seven areas.

The second area - the Willamette valley - had 50.8 of the state's teachers, according to the report, and the highest overall level of teacher preparation.

Gravity Affects Growth of Body

Iowa City, Iowa - (UP) - Gravity affects the rate of growth of the body with bones appearing to grow faster than other components in periods of increased gravity, according to a University of Iowa researcher.

Dr. Charles Wunder, assistant professor of physiology, said "this might lead one to the perhaps unstaffed prophecy that a person growing in a greater gravity such as Jupiter would be smaller but have relatively larger bones."

"One growing in a smaller gravity, such as found on the moon, might be larger but have relatively small bones," he said.

Wunder reported to the Iowa academy of Science on Research primarily aimed at studying the factors which control growth. However, he noted the findings will be important when man begins his trips into space.

Wunder said litters of mice have been conceived, delivered and reared at Iowa under artificial gravity two times as great as the normal "pull" of earth's gravity.

However, the animals decreased in size upon initial exposure to increased gravity. While they gain back and continue to grow, he said, they never actually attain the size of normal or control animals of the same age.

Volunteers Studied To the Federation of American Societies for Experimental Biology meeting here, they reported a study of 90 normal volunteers. Sixty women and 30 men received 600 milligrams of aspirin daily for seven days.

The average amount of blood loss per day for this group before they began taking the aspirin was less than one milliliter. However, 70 percent of these same persons showed a significant increase over this tiny amount while taking the aspirin, Dr. Watson reported.
