Madras Is Big Fashion Word Everywhere in '60

Madras is a finely-woven cotton in gay stripes or gingham-type plaids, like Joseph's coat—are of many colors—usually with an iridescent glow. The authentic Madras, hand-woven in India is characteristic in that no two pieces of the fabric are exactly alike. Also, the colors are said to "bleed" or run, when they are washed. Although years and years of research have gone into the development of true color, really-permanent dyes here—fashion's "hottest item" is an imported fabric—"guaranteed to bleed."

Since only limited amounts of the hand-loomed, "bleeding" Madras are available for use by American fashion makers, our leading textile mills are looming Madras plaids "like mad." The domestic Madras duplicate the subtle elegance and the richly-colored patterns of the Indian Madras to a "T" . . . yet they are washable by hand, or can join the rest of the "load" in the family washer. The term "Madras" was first used to describe a brightly-hued cotton cloth used by natives for their turbans. Since these turbans used were loomed in the mills of the Madras area in India, the term soon became synonymous with the cloth. The dyestuffs used in the authentic Madras cloth keep bleeding whenever wetted; this bleeding keeps blending the many colors of the pat-

tern, no matter how many times washed. This unique blending adds luster to the fabric. Rumor has it, that America is sending "foreign aid" to Madras—permanent dyes to give the Indian cloth—the modern treatment. A new, continental-cut dinner suit designed for American male tastes was recently introduced by Louis Jourdan, popular French-American designer, via a recent cover of the "Gentlemen's Quarterly"—the "Vogue" magazine of the men's fashion world. In fine, lightweight tropical worsted—ideal for year-round wear anywhere—the suit is distinguished by an angle shawl collar with braid trim. An unusual feature of this style is that the self-cumbersome pants is trimmed with the same braid as the lapels. The continental flavor in American dress, reflected in both formal and sportswear, is rapidly becoming the standard for men in most walks of life. "Less frills, more man" is the keynote of the various styles highlighted in "Gentlemen's Quarterly" for the new season.
