School District Voters Approve 60-61 Budget

Medford school district patrons yesterday approved the 1960-61 budget by a margin of 270 votes.

The unofficial vote was 2,191 for and 1,921 against adoption of the budget, which was defeated May 2 by 76 votes. A canvass of yesterday's vote is expected to start today by District Clerk Wilson Slater.

The 4,112 persons who voted yesterday represents the largest turnout of voters in the district for a school election anyone can remember. In the election May 2, a total of 2,856 patrons voted.

New Press Used Today to Print Edition of M-T

Today's issue of the Mail Tribune is being printed on its new press.

The 109-ton machine, erected by the Walter Scott Co., of Plainfield, N.J., has been undergoing test runs for the past week. Today, however, a full issue of the paper is being produced on all-new printing and stereotyping equipment.

Today's issue totals 24 pages, and more than 18,000 copies will be printed, using a total of more than six tons of newsprint.

The new press can print a maximum of 48,000 copies per hour, and can produce up to 48 pages at one time, compared to a speed of 26,000 copies per hour and a capacity of 16 pages at one time for the old press, which has been in service since 1931. An eight-page flatbed press was in use before that.

The new equipment also will provide greater flexibility in the use of color, which is becoming more and more popular in today's newspapers.

The press is housed in a new tawny-brick building constructed especially to house it on Grape st. The building also contains the stereotyping equipment, which makes the semi-circular metal castings which do the actual printing.

The building has large windows through which interested spectators can watch the press in action. A varicolored sidewalk on Grape st., and planters in which trees and shrubs will be located are also features of the new structure, which is across the alley from the Mail Tribune business, advertising, news-editorial and printing-composing room facilities facing on Fir st.

The composing room will be expanded into the space occupied by the old press after it is moved out.

Gromyko Expected To Veto Talk Bid

United Nations, N. Y. — Western diplomats predicted today Soviet Foreign Minister Andrei Gromyko would veto a small power appeal for the resumption of East-West peace talks under United Nations auspices.

Gromyko, voted down in his demand for a Security Council condemnation of American U2 flights and a needed by the dramatic disclosure that Soviet agents had planted listening devices in the great seal of the United States in the Moscow embassy, conceded the resolution has some merits.

But he claimed its main effect was to shield America's "Hitlerite" policy of aggression — a policy which he charged was openly embraced by President Eisenhower.

Khrushchev Can't Bully West, Truman Says

If Khrushchev thinks he can capitalize on the incident of the U2—with all the questions it raises and the clumsiness with which it had been handled—in order to throw the free world off balance, he has still a great deal to learn.

The greatest mistake he can make now is to assume that he can frighten or bully the West into surrender on his terms as a price for coexistence with him—which at best would mean a precarious peace.

I would suggest to Khrushchev that he stop his rocket rattling and probing for soft spots in the alliance of the free people of the world lest he go too far and blunder into danger.

Americans Making Sacrifices for Peace
The American people want peace and the world knows it. The American people are making and have been making great sacrifices in the interests of peace.

If Khrushchev thinks there is any clique in the United States that has the influence or the power to incite or maneuver the American people into war against their will, then he is totally ignorant about our people and our government. He is completely uninformed about how our people are governed and how our people check and retain control of those in whom they vest the authority of government.

Other dictators have grossly miscalculated in their failing to understand the determination and capacity of the American people to maintain their freedom.

I hope Khrushchev will not try to join the ranks of those who have misjudged us.

Dictators: Americans Won't Panic
I had to live through some crises with the Kremlin when I was President. And now, as a plain citizen, looking at the world situation, I would like to offer this observation to the dictators in the Kremlin: the American people cannot be panicked. They are patient and hopeful that peace can be maintained. They will support and encourage their government's efforts to find ways and means to secure the peace.

To this end the American people will see to it that we possess the necessary strength until such time as the United Nations will have the means of settling disputes and differences between nations.

Whatever problems of leadership we may have from time to time, we are a free people and can correct the things that need to be corrected.

But what throws an ominous shadow over the world is the self-perpetuating dictatorship in the Kremlin, where a handful of people supported by the military, imposes its will not only on its own people but is attempting to impose it on the rest of the world.

The principle source of the difficulties the world has been having in trying to establish a basis for peace is the Kremlin's ruthless dictatorship.

Gross Insult Hurled at Americans
Khrushchev even had the audacity to inject himself into our internal affairs and the coming elections by serving notice that he would no longer deal with us except through the next President, providing he finds the next President to his liking. Never has so gross an insult been hurled at the American people by the head of a nation.

What seems to me to be more to the point is that the free world would breathe easier and be more hopeful that peace could be possible if Dictator Khrushchev were succeeded by someone capable of more reason and sense and wiser in the ways of the world. I hope that some day the good people of Russia, who have never known free government, will join with other free peoples to put an end to dictatorships which are always provocative of wars.

Herter Believes Plane Incident Gave 'K' Fuel

Washington — Secretary of State Christian A. Herter acknowledged today that Soviet Premier Nikita Khrushchev might have found it impossible to torpedo the summit conference had it not been for the American spy plane incident.

"It is debatable whether it would have been possible for Mr. Khrushchev to devise another pretext for so radical and violent a position," Herter told the Senate Foreign Relations Committee.

Herter, lead-off witness at the committee's historic inquiry into the events leading to the summit collapse, cited two other major factors which in "combination," he said, probably impelled Russia to scuttle last week's Paris Big Four meeting.

Khrushchev's apparent conclusion that in the face of western unity, especially on the Berlin issue, "there was little likelihood of his having his way" at the summit.

"Serious questioning" and possibly outright opposition in the Soviet hierarchy to Khrushchev's personal diplomacy and so-called "softer" line toward the West. This probably was reinforced by bitter Chinese Communist opposition to Khrushchev's presumptuous attitude toward the West.

Zoning Hearing Is Set for West Side

A public hearing on proposed interim zoning for the West Side area will be held at the West Side school at 8 p.m., June 1, the Jackson county planning commission has announced.

Following the public hearing, the planning commission will study the proposal further and make its recommendations to the county court. The county court may call a further public hearing or may pass on the proposal.

Interim zoning means an area can be zoned for three years, after which area residents can vote it out. If they allow it to stand, it becomes law.

Approximately 175 persons attended a public hearing last night in the county courthouse for zoning of the White City area. The majority of persons attending seemed to favor the zoning, but wanted to know more about it. Copies of the proposed interim zoning ordinance were distributed to a nine-member committee which will consider it and a proposed county building code, and meet with the county planning commission in the near future.

Three Fined for Part in Fight

Medco Woods Pond Closed to Angling

Medco woods pond, located between Prospect and Butte Falls, was closed to all angling today by the Oregon state game commission to preserve the use of the reservoir as a salmon and steelhead rearing project.

Cole Rivers, game commission representative in southern Oregon, said control of public use is necessary to protect provisions of a lease with Medco R. D. Corporation. Attempts will be made to salvage catfish and trout when the pond is drained later this season, he said.

Two Burglaries Are Reported in City

Burglars broke into three offices on the fourth floor of the Levelette building, 205 West Main st., last night and took two typewriters and an adding machine from one of them.

Medford police said the equipment was taken from the Groomes Insurance company office. These appeared to be the only items missing, they said.

New Regime Tells Of Loyalty To West Alliances

Premier Menderis Placed Under Arrest

Turkey's pro-western army seized control of the government today in a midnight revolution and arrested Premier Adnan Menderes because it said his dictatorial regime was leading the country to "bloody fratricide" at a time of grave international crisis.

The army struck in the dead of night in what was believed to be a bloodless coup. There could be no significant opposition to the powerful army.

Shooting Reported
There were reports of shooting on the streets of Ankara early today but late diplomatic dispatches reaching London said the situation was now quiet.

Gen. Cemal Gursel, 62, commander of Turkey's American-trained and equipped forces, became the sole ruler of the country. He immediately pledged that he was "no dictator." He promised early elections and said Turkey would remain loyal to the western NATO and CENTO alliances.

Promises Honest Rule
Gursel also arrested President Celal Bayar, National Assembly President Refik Koraltan and other government leaders. The army indicated they and Menderes would be brought to trial.

Gursel formed a "national unity committee" and ordered local army garrisons to take over the cities where they were stationed. Subsequent broadcasts made it clear he was the boss, determined to establish a "clean and honest democratic order in the country as soon as possible."

Torn by Riots
"I hasten to tell all fellow countrymen that I am not by any means desirous of becoming a dictator," Gursel said in a broadcast to the nation, which has been torn by weeks of bloody student-led riots against the unpopular Menderes.

Gursel promised the nation freedom in a series of communiques and statements broadcast over Ankara Radio — the main source of information after the government imposed total censorship had sealed the nation's borders.

Jack Hoffbuhl will give the valedictory speech, and Joyce Hunter will present the salutatory.

Ernest R. James, superintendent of schools, will present senior class awards, and Merle W. Simmonds, chairman of the school board, will present diplomas.

The high school band and the girls vocal ensemble under the direction of Harry Kannasto, will provide music for commencement.

New Quake Rocks Chile As Planes Speed Relief

Santiago, Chile — A heavy new earthquake rocked Chile today, adding to the already incredible devastation that has taken a toll of 5,717 dead and missing since Sunday.

Planes En Route
The tremor hit while a fleet of 34 U.S. planes sped southward from the United States with 500 men and 400 tons of medicines and equipment.

The American mercy planes were joining, more than 70 aircraft and 10 helicopters from Chile's South American neighbors. The planes were expected by nightfall.

Official Figures
The government's official figures on casualties reported 1,898 identified dead and 3,570 missing. A United Press International tabulation of local reports showed 2,125 dead and missing.
