AMA Warns of Danger in Fitting Contact Lenses

Miami Beach, Fla. (Science Service) — The American Medical Association, long unofficially at odds with optometrists over contact lens fitting, has made its position official.

A resolution adopted here by AMA's policy making house of delegates states that "the use of such lenses (contact) is not entirely without hazard . . . the fitting of contact lenses is a proper medical function of the physician (and) that this house views with grave concern the indiscriminate use of contact lenses."

The resolution as it now stands is a milder version of the original submitted by Dr. Ralph O. Rycheimer, ophthalmologist of the National Medical Foundation for Eye Care in New York.
