FISHY FISH SCALE

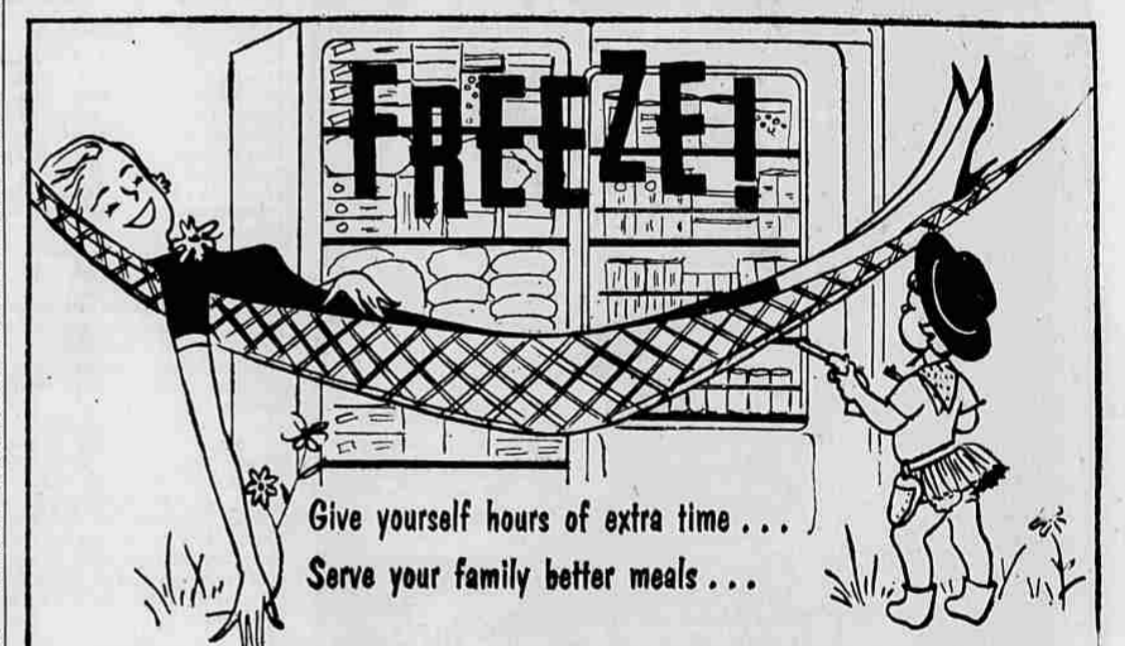
